

## ORDINANCE NO. 16-34.

By Mr. Altmaier.

Providing for the repair of certain streets and avenues in the City of Bexley.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO, three-fourths of all members elected thereto concurring:

Section 1. That the following streets, to-wit: Cassady Road near Plymouth; Euclaire Avenue from Main Street to Livingston Avenue; Fair Avenue from Drexel to Remington; Montrose from Main Street to Livingston Avenue; Plymouth from Dawson to Cassady; Remington Road from Main Street to Livingston; Sheridan Avenue from Main to Mound Street, and Vernon Road from Main Street to Livingston Avenue, be repaired by filling the cracks in the sheet asphalt pavement thereof, by repair of ruptures in pavement, by cutting out small holes in surface and filling same with cold bituminous material, by sheet asphalt patching, and by giving the entire surface an application of asphaltic emulsion, and covering the same with an application of pre-coated or mastic cushion sand, all in accordance with the plans and specifications therefor heretofore prepared by the engineers and now on file in the office of the Mayor, Department of Public Service.

Section 2. That the entire cost of said repairs shall be paid by the City of Bexley from the Maintenance and Repair of Streets, Motor Vehicle License Fund.

Section 3. That the sum of \$6,900.00 is hereby appropriated from said Maintenance and Repair of Streets, Motor Vehicle License Fund for the purpose of paying the cost of said repairs.

Section 4. That the Clerk be and he is hereby authorized and directed to advertise for bids for the making of said improvement and repairs according to law.

Section 5. This ordinance is an emergency ordinance necessary for the immediate preservation of the public peace and safety, such emergency being that places in said streets so in need of repair will render said streets unsafe for public traffic unless said repairs are promptly made, and said ordinance shall go into immediate effect.
