Authorizing the Mayor of the City of Bexley, Ohio, to enter into a contract on behalf of said City of Bexley with the City of Columbus, Ohio, for supplying said City of Bexley with the water from the municipal water system of said City of Columbus, Ohio.

BE IR ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor be and he is hereby authorized and directed to enter into a contract with the City of Columbus, Ohio, for the supplying of water to the City of Bexley and the inhabitants thereof, for the period of five years beginning October 1st, 1934, on the following terms and conditions:

That said City of Columbus, Ohio, shall supply said City of Bexley with surplus water from the water works and filtration plant of said City of Columbus, by delivering such water to said City of Bexley in cast iron pipes furnished and laid by said City of Bexley at its own cost and expense under Alum Creek and such streets of said City of Columbus and said City of Bexley and at such intersections of water mains of said City of Columbus as may be designated by the superintendent of the division of water of said City of Columbus, such water to be measured by meters of a type and capacity designated by the director of public service of said City of Columbus and said contract further provides that all mains, pipes, meters, services and mechanical connections for conducting such water supply shall be furnished, installed and maintained by said City of Bexley at its own cost, but in conformity with the plans therefor to be submitted to and approved by the director of public service of said City of Columbus and under his supervision, but the said City of Bexley is not thereby to be relieved of responsibility for the proper installation and maintenance, or create any liability on the part of said City of Columbus, and further providing that said City of Bexley shall have the right to use said water for all municipal purposes and to supply same to the inhabitants thereof and also to persons in the vicinity of said City of Bexley upon reasonable terms, it being provided in said contract that the furnishing of water to persons outside of said City of Bexley shall be upon terms and conditions subject to the approval and control of the director of public service and the city council of said City of Columbus, further that said City of Columbus shall have the right to tap the water mains of the City of Bexley for the water supply for the territory south and east of the City of Bexley, and further that said City of Columbus shall not be liable to said City of Bexley or its inhabitants or water consumers for failure or shortage of water supply; that said meters shall be read and the volume of water supplied to said City of Bexley shall be computed on or about the first days of April and October of each year, and that payment shall be made therefor by said City of Bexley to the City Treasurer of said City of Columbus within thirty days after the reading of said meters and the rendering of a bill therefor, at a rate of \$1.03 per 1,000 cubic feet. It being further provided that upon failure to pay for said water consumed as provided herein, the City of Columbus shall have the right to cut off water supply and said contract shall cease and terminate.

Section 2. That this ordinance is declared to be an emergency ordinance, and necessary for the immediate preservation of the public peace, health and safety, said emergency being that said water supply is necessary for domestic consumption and fire protection to the City of Bexley, for which reason this ordinance shall go into immediate force and effect.
