

ORDINANCE NO. 7-35.

Granting permission to The Standard Oil Company to remove curbs at entrance to driveways to filling station at the intersection of Main Street and Pleasant Ridge Avenue.

Whereas, The Standard Oil Company, a corporation under the laws of Ohio, has made application for a permit to construct a gasoline filling station on its premises at the southwest corner of Main Street and Pleasant Ridge Avenue in the City of Bexley, and has requested permission to remove the necessary curbs at the entrances to four driveways into said premises, two of said driveways being from Pleasant Ridge Avenue and two from Main Street, and

Whereas, a permit has been issued for such construction and Council is of the opinion that said request for the removal of said curbs should be granted subject to conditions hereinafter contained, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That privilege is hereby given to said The Standard Oil Company to remove curbing at the four entrances to the driveways into its premises at the southwest corner of Pleasant Ridge Avenue and Main Street, as follows, to-wit:- The west curb of Pleasant Ridge Avenue from the south line of Main Street south for a width of 55 feet; also from a point 61 feet south of the south line of Main Street south 17 feet; also the curb on the south side of Main Street from a point 9 feet west of the west line of Pleasant Ridge Avenue for a width of 24 feet; also from a point 73 feet west of the west line of Pleasant Ridge Avenue for a width of 18 feet.

Provided, however, that such permission to remove said curbs is conditioned upon said The Standard Oil Company agreeing that in the event it shall cease to use said premises for gasoline filling station purposes it will upon request of Council of the City of Bexley, and at its own expense, restore said curbing to the elevation existing prior to such removal, and that it will also restore ~~the~~ the surface of the ground adjacent thereto to the level existing prior to the removal of said curbs, which said agreement shall be evidenced by its acceptance in writing of the terms of this ordinance and therein agreeing to comply with all the provisions and conditions thereof.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law, and upon the acceptance thereof by the Standard Oil Company as hereinabove provided.
