

## ORDINANCE NO. 19-35.

By Mr. Altmaier.

Providing for the improvement of Bexley Park Road from Drexel Avenue to Remington Road by grading, curbing and paving the roadway thereof with asphalt, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That Council has determined and hereby does determine it to be necessary to improve Bexley Park Road from Drexel Avenue to Remington Road by grading, curbing and paving the roadway thereof with asphalt, and that it hereby determines to proceed with said improvement in accordance with the plans, specifications, estimates and profiles prepared by the engineers and on file in the office of the Mayor, which are hereby approved.

Section 2. That whereas, the Federal Emergency Administration of Public Works of the United States has proposed and agreed to furnish all labor in the making of said improvement, and a portion of the materials necessary therefor, and to perform said improvement on condition that the City of Bexley shall furnish the balance of said materials and the necessary engineering services, said balance of materials and engineering services being in the estimated amount of \$5,000.00, said improvement shall be made in accordance with said proposal and agreement and the Mayor is hereby authorized to enter into a contract for the purchase of said materials according to the plans, specifications, estimates and profiles hereinabove referred to, after advertisement had according to law.

Section 3. That the sum of \$5,000.00 is hereby appropriated from the Streets Maintenance and Repair Gasoline Tax Fund for the payment of the cost of said materials and engineering services.

Section 4. This ordinance is an emergency ordinance necessary for the immediate preservation of the public peace and safety, said emergency being that said street is fast deteriorating and becoming dangerous to traffic and is in need of immediate improvement, for which reason said ordinance shall go into immediate force and effect.
