

## ORDINANCE NO. 25-36.

To petition the Board of County Commissioners of Franklin County, Ohio, to erect a new township out of that portion of Marion Township which is included within the limits of the corporation of the City of Bexley.

WHEREAS, the City of Bexley is a municipal corporation under the laws of the State of Ohio, and as such has established a City Government for the conduct of its governmental affairs, and has its own duly elected officers separate from the township officials of Marion Township, with the exception of the offices of Justice of the Peace and Constable, and

WHEREAS, this Council recognizes a corresponding right on behalf of the remaining portion of Marion Township to elect its officials, provide its own revenues and conduct its own governmental affairs, separately from the City of Bexley, it is, in the opinion of Council, desirable that a new township be erected out of the portion of Marion Township included within the limits of the corporation of the City of Bexley, the same to be known as Bexley Township, and that the Board of County Commissioners of Franklin County, Ohio, be petitioned for that purpose, NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO, a majority of all members elected thereto concurring:

Section 1. That the Council of the City of Bexley does hereby petition the Board of County Commissioners of Franklin County, Ohio, to erect a new township out of that portion of Marion Township which is included within the limits of the municipal corporation of the City of Bexley, in accordance with the provisions of Section 3249, and related sections of the General Code of Ohio, and that said Board cause a proper adjustment of the rights and liabilities, and apportionment of the funds in the Treasury of said Township of Marion, to be made between the said new township so to be erected and the remaining portion of Marion Township, according to the statute made and provided.

The territory included within the corporate limits of Bexley and so petitioned to be erected into a new township, are specifically described as follows:

Situate in the County of Franklin, State of Ohio, and in the City of Bexley:

Beginning at a point in the south line of the P. C. C. & St. L. Railroad at its intersection with the east line of Stanwood Road; thence south along the east line of said Stanwood Road to the north line of Bellwood Ave.; thence east along the north line of Bellwood Ave., 182 ft. more or less to the east line of Bellwood Addition; thence south with said east line of Bellwood Addition to a point 200 ft. northerly from the center line of Maryland Avenue; thence east 200 ft. northerly and parallel with the said center line of Maryland Ave., to the east line of Marion Township; thence southerly with said east line of Marion Township to the north line of Livingston Avenue; thence westerly along the north line of Livingston Ave. to the center of Alum Creek; thence northerly with the meanders of said Creek to a point in the center of said Creek on the center line of Fair Avenue produced; thence easterly with the center line of Fair Avenue and the center line of Fair Avenue produced to the center line of Parkview Avenue; thence northerly with the center line of Parkview Ave. to its intersection with the center line of Dale Avenue; thence westerly, on the center line of Dale Avenue, to the west line of the alley west of Dale Ave.; thence northerly with said west line, which west line is the east corporation line of the City of Columbus, to a point on the center line of E. Broad St.; thence westerly with said center line of E. Broad St. to a point in the center line of Alum Creek; thence northerly with the center line of Alum Creek to a point in the south right-of-way line of the P. C. C. & St. L. Railroad; thence easterly along said south line of said railroad to the place of beginning.

Section 2. That a duly authenticated copy of this ordinance, and of that part of the minutes of this meeting relating to the passage of this ordinance, be certified by the Clerk of Council to the Board of County Commissioners of Franklin County, Ohio, as and for the petition of this Council for the erection of a new township as hereinabove provided.

Section 3. This ordinance is an emergency ordinance, necessary for the preservation of the public peace, health and safety, said emergency being that the annual budget of the respective portions of said township cannot be properly provided for until the carrying out of the provisions of this ordinance, wherefore, said ordinance shall go into immediate force and effect.
