

ORDINANCE NO. 8-37

By Mr. Stackhouse.

To authorize the settlement and payment of the claim of Talmadge Edwards.

Whereas, on the 11th day of November, 1936, at or about the hour of 7:15 P.M., of said day, Talmadge Edwards was walking south across Main Street at or about the intersection thereof with Montrose Avenue, at which time and place he was struck by the Chevrolet automobile used as a police cruiser and owned by the City of Bexley, which was then being driven by Ralph A. Antle, police officer of said City, said accident resulting in a fracture of the leg of the said Talmadge Edwards, together with other physical injuries, and

Whereas, the said Talmadge Edwards has suffered damages to his person and by way of loss of time from his work, and has incurred expenditures by reason thereof in excess of the sum of \$250.00, and

Whereas, said accident occurred under circumstances which would apparently warrant the recognition thereof as a moral obligation on the part of the City of Bexley, NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That conditioned upon the agreement of the said Talmadge Edwards to receive from the City of Bexley the sum of \$250.00 in full of all claims for damages to his person or property arising out of said accident hereinabove described, and upon his execution of his release to the City of Bexley and the said Ralph A. Antle, from all such damages arising out of said accident, said claim in said sum be and the same is recognized as a moral obligation of the City of Bexley, and upon the receipt of said release properly executed to the approval of the City Solicitor, the proper officials of the City are authorized to issue a check of the City in said sum of \$250.00 to the said Talmadge Edwards in full of all damages arising out of said accident.

Section 2. That for the purpose of paying said claim, there be and hereby is appropriated from the General Fund the sum of \$250.00.

Section 3. That said ordinance shall take effect and be in


force from and after the earliest period allowed by law.
