ORDINANCE NO. 10-37

Regulating the deposit of building materials, tools, or appliances upon the streets and highways.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That no person, persons, firm or corporation, or their agents or employees, shall in any manner use any of the public streets or highways in the City of Bexley by depositing, storing or maintaining, or causing to be deposited, stored or maintained building materials, tools or appliances upon the improved or traveled portions thereof, nor upon any sidewalks, and in case there are no sidewalks along any such street, such materials, tools or appliances shall not be deposited or maintained within six feet of the curb line of such street or highway, for a longer period than may be reasonably necessary for the unloading and removal thereof, and if there are no such curb line established, then such materials, tools or appliances shall not be deposited or maintained within six feet of the traveled or used portion of such street or highway.

Section 2. Provided, however, in cases where by reason of the proximity to the street or highway of the building or buildings upon which such materials, tools or appliances are to be used, it is in the opinion of the mayor necessary to deposit such building materials, tools or appliances upon the street or sidewalk area, the mayor may upon application issue a permit therefor, such permit to designate the part or parts of such street or sidewalk area whereon such materials, tools or appliances shall be deposited, and any such deposit shall be in accordance with the permit so issued.

shall be mixed upon any of the streets, alleys or sidewalks in the City of Bexley, except in concrete mixing machines, or in boxes, the bottoms of which are tight and non-leaking. Upon the completion of the work in which such machines or boxes are used, as above provided, the street, sidewalk or alley shall be thoroughly cleaned and all mortar, sand or gravel, or refuse matter and materials shall be completely removed, and said machines and boxes shall be taken from the street or highway.

Section 4. Whenever any such public streets or sidewalk areas a re used as provided in Sections 2 or 3 of this ordinance, the person, persons, firm or corporation, or their agents or employees, as the case may be, shall place and keep on such materials, tools, appliances, machines or boxes, from sunset to sunrise, a lighted lantern with red glass, and whenever the space occupied exceeds tenfeet in length or breadth, one such lantern shall be placed at each end thereof.

Section 5. Any person violating any of the provisions of this ordinance shall, upon conviction thereof, be fined not less than \$10.00 nor more than \$50.00, together with the costs of prosecution.

Section 6. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
