

ORDINANCE NO. 11-37

To provide for the extension of the contract of the General Electric Company for the purchase of large incandescent lamps.

Whereas, the City of Bexley, under date of March 1st, 1936, after advertisement had according to law, duly entered into a contract with the General Electric Company for the purchase of large incandescent General Electric Mazda lamps and General Electric type "D" lamps of the sizes, types and classes listed in the schedules mentioned in said contract, in which said contract the City agreed that it would take within one year from date thereof such lamps amounting to not less than \$1200.00 net value, in accordance with said Company's current price schedules, which estimate was therein accepted by said General Electric Company as a basis for billing only, and it agreed to invoice said lamps based upon said estimates at the following discounts from said list prices given in its schedules, to-wit: Standard Package Quantity 27%, and on Broken Package Quantity on Mazda Lamps only 17%, and

Whereas, under said contract said City did not during said year ending on the 1st day of March, 1937, take said full estimated quantity of \$1200.00 worth of said lamps, and would not under the terms of said contract be entitled to said discounts, but said General Electric Company is willing to extend said one year period for such further period of time as said City shall take such additional amount of lamps as to make a total taken under said contract in the value of \$1200.00, said extension to be upon all the terms and conditions contained in said original contract, and

Whereas, council is of the opinion that it would be to the best interests of the City to extend said contract, and that the same not involving further expenditure of monies provided in said former contract, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That in order to save to the City of Bexley the discounts provided in said contract of the General Electric Company hereinabove set forth, both upon the lamps which were taken during the year beginning March 1st, 1936 and upon the remaining portion of said lamps so contracted for in the total sum of \$1200.00 in value, the Mayor and Auditor are hereby authorized to enter into an extension of said

agreement with the General Electric Company for such period of time from and after March 1st, 1937 as will enable said General Electric Company, under the requirements of the City, to furnish the remaining portion of said lamps so contracted for in the total sum of \$1200.00, said extension to be subject to all the agreements terms, conditions and discounts contained in said original agreement.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
