

## ORDINANCE NO. 12-37

By Mr. Stackhouse.

Providing for the improvement of Fair Avenue from Remington Road to Gould Road, in cooperation with the Works Progress Administration, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That council has determined and hereby does determine that it is necessary to improve Fair Avenue from Remington Road to Gould Road by grading, draining, paving the roadway thereof with water bound macadam base and two inch Black Top surface, constructing concrete curbs and gutters and installing approximately 440 feet of 8 inch C. I. Watermains, with necessary water connections, and that it hereby determines to proceed with said improvement, all in accordance with the plans, specifications, estimates and profiles prepared by the engineers and on file in the office of the mayor, which are hereby approved.

Section 2. Whereas, the Works Progress Administration of the Public Works of the United States has proposed and agreed to furnish all labor in the making of said improvement, and a portion of the materials necessary therefor, and to make and perform said improvement on condition that the City of Bexley shall furnish the balance of said materials in the estimated sum of \$6584.00, and equipment rental in the estimated sum of \$2840.00 and other direct costs including engineering services, in the estimated sum of \$1425.00 being a total estimated amount to be furnished by the City of Bexley in the amount of \$10,849.00, and being twenty-five per cent of the estimated cost of said improvement, and

Whereas, Lillian G. Johnson, being the owner of certain premises located on that part of Fair Avenue hereinabove described, on behalf of herself, and the other owners of premises fronting and abutting upon Fair Avenue, has heretofore paid to the Jennings-Lawrance Company the sum of \$500.00 for the preparation of the necessary plans, specifications, estimates and profiles for said improvement, and has paid to and deposited with the Auditor of the City of Bexley the further sum of \$10,349.00, under her written agreement on behalf of herself and said other property owners that the same shall be applied by the City of Bexley to pay its portion of the cost of said improvement

less, however, the cost of the necessary water taps, which taps shall be paid in full by the City of Bexley and a service charge therefor shall be made to the individual owners at the time they shall connect therewith, now, therefore, the Council does ordain that said improvement shall be made in accordance with said proposal and agreement, and the Mayor is hereby authorized to enter into a contract for the purchase of said materials according to the plans, specifications, estimates and profiles hereinabove referred to, after advertisement had according to law, and the said Works Progress Administration is hereby authorized to enter upon said street and to cause said improvement to be made in accordance with the foregoing provisions of this ordinance.

Section 3. That said sum of \$10,349.00 so deposited by the said Lillian G. Johnson, as hereinabove recited, or so much thereof as may be necessary for the purposes hereinabove set forth, is hereby appropriated for said improvement, and the sum of \$1,144.00 is hereby appropriated from the water fund for the making of said water taps.

Section 4. This ordinance is an emergency ordinance, necessary for the immediate preservation of the public, peace, health and safety, said emergency being that residences are being constructed on said street, and that the same is dangerous to traffic and is in need of immediate improvement, for which reason this ordinance shall go into immediate force and effect.
