ORDINANCE NO. 27-37

By Mr. O. F. Rehn.

To fix the compensation of laborers and employees, and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY. STATE OF OHIO:

Section 1. That subject to the limitations prescribed by the Charter the Superintendents of the Divisions of Streets, Parks, Water and Buildings shall have the right to employ such laborers or employees as may from time to time be necessary in the conduct of the affairs of their respective departments.

Section 2. Common or unskilled laborers so employed shall be classified in the following classes, to-wit: a, b, c, d, e, f, g, h, and they shall be paid the following compensation, to-wit:

```
Class (a) laborers shall receive 40 cents per hour class (b) laborers shall receive 45 cents per hour class (c) laborers shall receive 50 cents per hour class (d) laborers shall receive 55 cents per hour class (e) laborers shall receive 65 cents per hour class (f) laborers shall receive 65 cents per hour class (g) laborers shall receive 70 cents per hour class (h) laborers shall receive 75 cents per hour class (f) laborers shall receive 80 cents per hour class (f) laborers shall receive 80 cents per hour
```

Section 3. Employees whose services are but casual shall be classified in the following classes, to-wit: a, b, c, d, e, f, and g, and they shall be paid the following compensation, to-wit:

```
Class (a) employees shall receive 85 cents per hour class (b) employees shall receive 90 cents per hour class (c) employees shall receive 95 cents per hour class (d) employees shall receive $1.00 per hour class (e) employees shall receive $1.10 per hour class (f) employees shall receive $1.20 per hour class (g) employees shall receive $1.30 per hour
```

Section 4. Trucks and drivers so employed shall be classified as a, b and c. Class (a) shall receive \$1.00 per hour; Class (b) shall receive \$1.50 per hour; Class (c) shall receive \$2.00 per hour.

Section 5. All bills for labor shall be approved by the Mayor and shall be paid from the appropriation for the Department in which said services shall have been rendered.

Lection 6. Ordinance No. 21-35, passed June 11th, 1935, is hereby repealed.

Section 7. This ordinance is an emergency ordinance necessary for the immediate preservation of the public peace, health

and safety, and rhall go into immediate effect.
