ORDINANCE NO. 28-37

Granting permission to Charlotte Lindenberg to remove curb and construct a driveway on Lot 364, Bexley Park Addition.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That whereas, Charlotte Lindenberg, being the owner of Lot No. 36% Bexley Park Addition in the City of Bexley, has leased said lot to The Kroger Grocery & Baking Company for parking purposes in connection with its store building being constructed es Numbers 2532-2534 East Main Street, in the City of Berley, and has requested permission of Council to construct a driveway of approximately 18 feet in width from Main Street on to said premises, and for that purpose to remove sufficient of the north curb of Main Street for the purpose of constructing said driveway with circular curb on each side thereof having 6 foot radii, and Council being of the opinion that such permission should be granted, said permission is hereby accordingly granted, and said Charlotte Lindenberg is authorized to construct such driveway approximately 18 feet in width to said premises, and to remove the curb to a distance of approximately 30 feet. In constructing said driveway the gutters and sidewalks shall be restored to their present levels, and said con truction shall be in accordance with the provisions of the ordinance prescribing the specifications for driveways and shall be to the satisfaction of the engineers of the City of Bexley.

Section 2. At such time as said lot shall the to be used for parking purposes, as hereinabove described, said Charlotte Lindenberg, her heirs and assigns, shall upon request of the City restore said curb at the entrance to said driveway to its present location and condition, and this ordinance shall not become effective until said Charlotte Lindenberg shall accept in writing the provisions and agree to carry out the terms thereof.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law, upon the acceptance thereof as hereinabove provided.
