ORDINANCE NO. 37-37

To amend Section 59 of Ordinance No. 47-36 establishing a traffic code for the City of Bexley, Ohio, passed November 24th, 1936.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That Section 59 of Ordinance No. 47-36, establishing a traffic code for the City of Bexley, Ohio, passed November 24th, 1936, be and the same is hereby amended to read as follows:-

Section 59. RESTRICTIONS AS TO SPEED. a. No person shall operate a motor vehicle or motorcycle in or upon the public streets, roads or highways at a speed greater or less than is reasonable or proper, having due regard to the traffic, surface and width of the street, road or highway, and of any other conditions then existing, and no person shall drive any motor vehicle in and upon any public street, road or highway at a greater speed than will permit him to bring it to a stop within the assured clear distance ahead.

It shall be prima facie lawful for the operator of a motor vehicle to drive the same at a speed not exceeding the following:-

Twenty miles per hour when passing a school building or the grounds thereof during school recess and while children are going to or leaving school during the opening or closing hours.

Twenty miles per hour in the business or closely built up portions of the municipal corporation.

Twenty five miles per hour in all other portions of the municipal corporation, except on state routes and on main Thoroughfares.

Thirty five miles per hour on state routes or main thoroughfares within the municipal corporation outside business portions thereof.

It shall be prima facie unlawful for any person to exceed any of the foregoing speed limitations. In every charge of

violation of this section the complaint, also the summons or notice to appear, shall specify the speed at which the defendant is alleged to have driven, also the speed, if any, which this section declares shall be prima facie lawful at the time and place of such alleged violation.

- b. No person shall operate a street car upon the streets of the City of Bexley at a greater rate of speed than twenty-five miles per hour.
- c. No person shall operate an ambulance in excess of the speed limits established by law for motor vehicles, and any person operating an ambulance shall stop such vehicle in the right side of the street and shall drive the same in a careful manner with due regard for the safety and convenience of other vehicles and pedestrians.
- d. No person shall turn a vehicle at any corner at a rate of speed exceeding one-third the otherwise legal speed limits at that place.

Section 2. Any person violating any of the provisions of this section shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not more than \$25.00, and for the second or subsequent offense shall be fined not more than \$50.00, together with the costs of prosecution.

Section 3. That said Section 59 of said Ordinance No. 47-36 be and the same is hereby repealed.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
