

ORDINANCE NO. 24-58

By Mr. Stackhouse-

To provide for the issue of notes in anticipation of the levy of special assessments and in anticipation of the issuance of bonds in anticipation of the collection of special assessments for the improvement of the alleys therein named by grading and paving, and constructing necessary drains in cooperation with the Works Progress Administration of the United States of America, and declaring an emergency.

Whereas, the council of the City of Bexley has heretofore by proper legislation declared the necessity of improving certain alleys hereinafter named, by grading and paving the same and constructing necessary drains, and,

Whereas, this council contemplates the use of \$108,500.00 for the purpose of paying the portion of the cost of said improvement, which is to be paid by assessment, and it will require not to exceed \$3000.00 to care for interest maturing previous to the receipt of the assessments from which such interest is ultimately to be paid, either upon the bonds or notes hereinafter provided for, making an aggregate amount of \$111,500.00 NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO: Three-fourths of all members elected thereto concurring:

Section 1. That it is hereby declared necessary to issue the bonds of the City of Bexley in the principal sum of \$111,500.00 for the purpose of raising money in anticipation of the collection of special assessments for the improvement of the following described alleys in the City of Bexley, to-wit:

1. Alley East of Grandon Avenue, from the alley south of Main Street to alley north of Livingston Avenue.
2. Alley East of Roosevelt Avenue, from the alley south of Main Street to alley north of Livingston Avenue.
3. Alley East of Vernon Road, from the alley south of Main Street to alley north of Livingston Avenue.
4. Alley East of Remington Road, from the alley south of Main Street to alley north of Livingston Avenue.
5. Alley East of Montrose Avenue, from Round Street to alley north of Livingston Avenue.
6. Alley East of Cassingham Road, from alley south of Main Street to alley north of Livingston Avenue.
7. Alley East of Euclaire Avenue, from alley south of Main Street to alley north of Havenwood Drive North.

8. Alley West of Euclaire Avenue, from Main Street to alley north of Livingston Avenue.
9. Alley South of Main Street, from Remington Road to Chelsea Avenue.
10. Alley North of Havenwood Drive North, from Euclaire Avenue to Cassingham Road.
11. Alley North of Livingston Avenue, from Cassingham Road to Chelsea Avenue.
12. Alley North of Main Street, from 185 feet west of Dawson Avenue to east end thereof.
13. Alley North of Sherwood Road, from alley east of Drexel Avenue to Remington Road.
14. Alley North of Bryden Road, from alley east of Drexel Avenue to Remington Road.
15. Alley North of Bailey Park Road, from alley east of Drexel Avenue to Cassidy Road.
16. Alley East of Drexel Avenue, from Fair Avenue to Sherwood Road.
17. Alley West of Cassidy Road, from Plymouth Avenue to Elm Avenue.
18. Alley East of Cassidy Road, from Dale Avenue to alley south of Broad Street.
19. Alley East of Ardmore Road, from Dale Avenue to alley south of Broad Street.
20. Alley East of Cassingham Road, from alley south of Broad Street to Elm Avenue.
21. Alley East of Remington Road, from alley south of Broad Street to Elm Avenue.
22. Alley East of Starwood Road, from alley south of Broad Street to south end thereof.
23. Alley South of Broad Street, from Cassidy Road to Roosevelt Avenue.
24. Second Alley South of Broad Street, from Cassidy Road to Roosevelt Avenue.
25. Alley North of Broad Street, from Cassidy Road to east end thereof.
26. Alley East of Cassidy Road, from alley north of Broad Street to Ruhl Avenue.
27. Alley East of Ardmore Road, from alley north of Broad Street to Ruhl Avenue.
28. Alley East of Cassingham Road, from alley north of Broad Street to Ruhl Avenue.
29. Alley East of Remington Road, from alley north of Broad Street to Ruhl Avenue.
30. Alley South of Fair Avenue from alley east of Drexel Avenue to Remington Road.

Section 2. That said bonds shall be of the denomination of \$1000.00, and shall be dated ^{December} ~~November~~ 15, 1959; shall bear interest at the rate of 3% per annum, payable semi-annually, on the 1st days of April and October of each year until the principal sum is paid, and shall mature in five annual installments after their issuance.

Section 3 That for the purpose of raising money in anticipation of the levy of special assessments and in anticipation of the issuance of bonds in anticipation of the collection of special assessments for the improvement of the above named

alleys by grading and paving, or otherwise improving the same, in accordance with the legislation heretofore passed by the city council with respect thereto, to pay the property owners' share of the cost and expense of said improvement, it is hereby declared necessary to issue, and there shall be issued, notes of said city in the amount of \$111,500.00 which shall be placed to the credit of the paving funds of said alleys.

Provided, however, that the appropriation hereinabove made for the paving of said alleys is subject to the qualification that interest at the rate of 2% per annum for the period prior to the collection of the first installment so to be levied shall be included in said respective amounts, and the amount necessary to pay said interest is hereby appropriated for the payment thereof and for no other purpose and the respective amounts above set forth shall be reduced by the apportioned amounts for the payment of said interest.

Section 4. That such anticipatory notes in the amount aforesaid shall be issued bearing interest at the rate of 2% per annum, payable semi-annually. Such notes shall be dated the 15th day of June, 1938, and shall mature on December 15th, 1939. Such notes shall be executed and delivered in such number and such denominations as may be requested by the purchaser of such notes.

Section 5. Such notes shall be executed by the Mayor and City Auditor and shall bear the seal of the corporation. They shall be payable at the office of the Auditor in the City of Berley, Ohio; they shall express upon their face the purpose for which they are issued and that they are issued pursuant to this ordinance.

Section 6. All assessments collected for the improvements aforesaid and unexpended balances remaining in the funds after the costs and expenses of said improvements have been paid, shall be applied to the payment of said notes and the interest thereon until both are fully provided for.

Section 7. Said notes shall be first offered to the Sinking Fund Trustees of the city and so many of the same as shall not be taken by said trustees shall be sold at private sale by the city auditor, but for not less than par and accrued interest, and the proceeds from such sale, except any premium and accrued interest thereon (and the amount necessary for the payment of interest prior to the maturity of said notes), shall be paid into the proper fund and used for the purpose aforesaid and for no other purpose. Any premium and accrued interest (and the amount necessary for the payment of interest prior to their maturity) shall be transferred to the Sinking Fund to be applied in the payment of principal and interest of said notes in the manner provided by law.

Section 8. Said notes shall be the full general obligations of the city, and the full faith, credit and revenue of said city are hereby pledged for the prompt payment of the same. The par value to be received from the sale of the bonds anticipated by said notes and any excess fund resulting from the issuance of said notes shall, to the extent necessary, be used only for the retirement of said notes at maturity, together with interest thereon, and is hereby pledged for such purpose.

Section 9. In the event that such assessments are not levied or bonds are not issued to provide a fund for the payment of said notes at maturity, a general tax shall be levied against all of the property in said city for the payment of such notes and the interest thereon.

Section 10. The City Auditor is hereby directed to forward a certified copy of this ordinance to the County Auditor.

Section 11. That this ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being that said alleys are in an impassible condition and dangerous to traffic and should be improved without delay, and said ordinance shall go into immediate force and effect.
