

ORDINANCE NO. 31 28

By Mr. Betz:

To vacate that part of the second alley south of Astor Avenue extending from Euclaire Avenue to the first alley west of Euclaire Avenue.

Whereas, on the 14th day of June, 1938 a petition and consent of persons owning all the lots and lands bounding and abutting upon that part of the second alley south of Astor Avenue extending from Euclaire Avenue to the first alley west of Euclaire Avenue was duly presented to Council praying that said alley between said points be vacated, as provided in Section 5727 of the General Code, and further requesting and consenting that if the petition be granted the City reserve for itself, the public and quasi-public corporations, now or hereafter holding franchises and permits from the City for the supplying of water, gas, electricity, telephone service, and all necessary easements in, under or over said portion of said alley, for the purpose of sewers, mains, poles, wires and conduits, and maintaining and keeping them in repair so far as the City may deem necessary to supply its inhabitants with public utility service, sewers and drains, and

Whereas, Council upon hearing is satisfied that there is good cause for such vacation as prayed for and that such vacation will not be detrimental to the general interests and finds that said petition and consent have been signed by all of the owners of the lots and lands bounding and abutting upon said alley between said points, NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BRELEY, STATE OF OHIO:

Section 1. That that part of the second alley south of Astor Avenue extending from Euclaire Avenue to the first alley west of Euclaire Avenue in said City be and the same is hereby vacated; reserving, however, for the City, the public

and quasi-public corporations, now or hereafter holding franchises and permits from the City for the supplying of water, gas, electricity, telephone service and all necessary easements in, under or over said portion of said alley, for the purpose of sewers, mains, poles, wires and conduits and maintaining and keeping them in repair so far as the City may deem to be necessary to supply its inhabitants with public utility service, sewers and drains.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
