

ORDINANCE NO. 36-38

Granting permission to Glass Bowl, Inc., to remove the curb at entrance to driveway to its premises on East Main Street.

Whereas, the Glass Bowl, Inc., a corporation, has requested permission to remove the necessary curb therefor, and to construct a driveway into its premises on East Main Street, being Lot No. 367 and the east one-half of Lot 368, of Bexley Park Addition, in said City, and whereas, Council is of the opinion that said permission should be granted in accordance with said request, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That permission be and is hereby granted to Glass Bowl, Inc., to construct an 18 foot driveway into its premises on East Main Street, being lot No. 367 and the east one-half of Lot 368 of Bexley Park Addition, in said City, said driveway to be on said east one-half of Lot 368, and to remove the necessary curbing along the north side of Main Street, a distance of approximately 29 feet, and to construct new curbing at the entrance to said driveway, said curbing to be circular with 6 foot radii on each side thereof, Said Glass Bowl, Inc., shall construct or cause to be constructed a concrete entrance to said driveway, extending from the street pavement to the inside line of the sidewalk, and for that purpose may remove the necessary portions of the present sidewalk so as to make a safe and continuance driveway, as well as concrete sidewalk.

The removing of said curbing and the construction of said new curbs and concrete entrance and sidewalk shall be done under the supervision of the engineers and Superintendent of Streets, and to their satisfaction, in accordance with the plans and specifications on file in the office of the Mayor, and all cost

and work shall be done at the expense of said Glass Bowl, Inc., and it shall place proper warnings and signals to guard the public against danger during the progress of said construction.

Section 2. Providing, however, that such permission to remove said curb is conditioned upon the said Glass Bowl, Inc., agreeing that in the event said premises shall cease to be used for restaurant or similar purposes, it or its assigns will upon request of the Council of the City, and at its own expense restore said curbing to its former location and elevation, and will also restore the surface of the ground and street adjacent thereto, to the level existing prior to the removal of said curb, which said agreement shall be evidenced by its acceptance in writing to the terms of this ordinance, and therein agreeing to comply with all the conditions and provisions thereof.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law, and upon the acceptance thereof by said Glass Bowl, Inc., hereinabove provided.
