To vacate that part of the first alley south of Astor Avenue extending from Remington Road to Vernon Road.

Whereas, on the 12th day of December, 1938, a petition and consent of all persons owning all the lots and lands bounding and abutting upon that part of the first alley south of Astor Avenue extending from Remington Road to Vernon Road was duly presented to council that said alley between said points be vacated as provided in Section 3727 of the General Code, and further requesting and consenting that if baid petition be granted the City reserve for itself, the public and quasi public corporations, now or hemeafter holding franchises and permits from the City for the supplying of water, gas, electricity, telephone service, all necessary esstments in, under and over said part of said alley, for the purpose of sewers, mains, poles, , wires and conduits and maintaining and keeping them in repair so far as the City may deem it to be necessary to supply its inhabitants with public utility service, sewers and drains, and

Whereas, Council upon hearing is satisfied that there is good cause for such vacation as prayed for that such vacation will not be detrimental to the general interests and finds that said potition and consent have been signed by all of the owners of lots and lands bounding and abutting upon said alley between said points, NOW, THIRREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF EMPLEY, STATE OF OMIO:

Section 1. That that part of the first alley south of Astor Avenue extending from Remington Road to Vernon Road, in the City of Bexley, be and the same is hereby vacated; reserving, however, for the City, and the public and quasipublic corporations, now or hereafter holding franchises and

permits from the City for the supplying of water, gas, electricity, telephone service, all necessary essements in, under and over said part of said alley for the purpose of severs, mains, poles, wires and conduits and maintaining and keeping them in repair so far as the Sity may deem it to be necessary to supply its inhabitants with public utility service, sewers and drains.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
