

## ORDINANCE NO. 18-39

Providing for deferred payments for cost of water connections and taps for premises at Nos. 984 and 998 Francis Avenue.

Whereas, under authority of Ordinance No. 35-34, duly passed on October 23rd, 1934, council provided for the construction of water mains in Livingston Avenue from College Avenue to Euclaire Avenue, and a water line connecting therewith in Francis Avenue and extending northerly a distance of 330 feet, said construction to be in cooperation with the Federal Emergency Relief Administration, the cost of which shall be paid from the water fund and said fund to be reimbursed by a proper charge to be fixed by council and to be paid by the owners of properties bounding and abutting upon said water lines, which said proper charge has been fixed by council in the sum of \$50.00 for each connection, and

Whereas, Flaval A. Black and Lillian M. Black, being the owners of premises at No. 984 Francis Avenue, and Earl N. Ronemus and Alberta T. Ronemus, being the owners of premises at No. 998 Francis Avenue, are desirous of making such water connections and constructing taps to their respective premises, said respective taps costing \$33.00 each, making a total of \$83.00 charges against each of said premises for said connections and taps, and

Whereas, said respective property owners represent that they are unable to pay said costs in a lump sum, and have executed their respective agreements that in consideration that the city shall cause said connections to be made and said taps to be constructed that they will each pay the cost thereof at the rate of \$5.00 per month from and after the date of such connections, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Superintendent of Water be and he is hereby instructed to cause such water connections to be made and said taps to be constructed, and to collect and pay into the water fund said amounts of \$83.00 due from the owners of each of said premises in monthly installments of \$5.00 each, which said sum shall be deposited to the credit of the Water Fund.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
