

ORDINANCE NO. 28-39

To provide for the cost of re-locating sidewalks on North Ardmore Road, North Cassingham Road and North Remington Road, between Broad Street and Maryland Avenue, and declaring an emergency.

Whereas, Council has heretofore re-established the location and grade for sidewalks on North Ardmore Road, North Cassingham Road and North Remington Road, between Broad Street and Maryland Avenue, and, whereas, certain property owners abutting upon said streets prior to said change of location and grade constructed sidewalks along their respective premises, which sidewalks are not in the locations and grades so established, some of which said walks, or portions thereof, are in good condition, and of value to said property owners, and, whereas, the Works Progress Administration of the Federal Government has agreed to furnish the labor for constructing new sidewalks at said established location and grade, if the property owners will furnish the materials therefor, and

Whereas, certain property owners have indicated their desire to so construct new sidewalks in cooperation with said Works Progress Administration, and it will be equitable if the City of Bexley will reimburse said property owners so constructing new sidewalks for the value of their existing sidewalks so constructed as hereinabove mentioned, and

Whereas, an appraisal of the values of said sidewalks has been made by the engineers and Superintendent of Streets, which valuation is on file in the office of the Clerk in the total sum of \$1701.30, and, whereas, it is estimated that it will cost the sum of \$158.40 to construct sidewalks at the intersections of said streets, and the sum of \$240.30 for engineering and incidental expenses connected therewith, making a total cost of \$2100.00 for all of said above purposes, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the City of Bexley does hereby authorize and permit the property owners abutting upon North Ardmore Road, North Cassingham Road and North Remington Road, between Broad Street and

Maryland Avenue, in cooperation with Works Progress Administration, to construct sidewalks upon the re-established location and grade along said streets, and the City shall reimburse such respective property owners for the appraised value of their existing sidewalks constructed as hereinabove described in accordance with said appraisal now on file in the office of the Clerk, and the Superintendent of Streets is authorized to cause said sidewalks to be constructed at the street intersections between said points by said Works Progress Administration, said City to furnish the materials for said intersections.

Section 2. That the sum of \$2100.00 is hereby appropriated from the general fund for the purpose of paying the costs hereinabove provided.

Section 3. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, and same shall go into immediate force and effect.
