

ORDINANCE NO. 58-39

Withdrawing certain alleys, and parts of alleys, from the improvement proceedings, under authority of Ordinance No. 23-38, passed May 10th, 1938.

Whereas, on the 10th day of May, 1938 the council duly passed an Ordinance No. 23-38, determining to proceed with the improvement of certain alleys in the City of Bexley, and therein described, in cooperation with the Works Progress Administration of the United States of America, and

Whereas, certain of the alleys, and parts of alleys, therein described, and thereby provided to be improved, have upon petition been vacated by ordinances duly passed, and council is of the opinion that certain others thereof should not be improved at this time, and notices of such improvement thereof have not been served upon the property owners, and it is desirable to withdraw the same from said proceedings to improve,
NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the alleys, and parts of alleys, hereinbelow described, be not improved at this time under the proceedings for said improvement as authorized by Ordinance No. 23-38, passed May 10th, 1938, which alleys, and parts of alleys, are described as follows, to-wit:

22. That part of the alley east of Stanwood Road between the first alley south of Broad Street and the second alley south of Broad Street.

25. That part of the alley north of Broad Street, from Stanwood Road east to the east end thereof.

26. That part of the alley east of North Cassady Road extending from Maryland Avenue to Ruhl Avenue.

27. That part of the alley east of North Ardmore Road extending from Maryland Avenue to Ruhl Avenue.


28. That part of the alley east of North Cassingham Road extending from Maryland Avenue to Ruhl Avenue.


29. That part of the alley east of Remington Road extending from Maryland Avenue to Ruhl Avenue.

The numbers opposite the above respective alleys and parts of alleys corresponds to the numbering contained in said Ordinance No. 28-38.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
