ORDINANCE NO. 68-39

Amending Section 31 of Ordinance No. 47-36, establishing a traffic code for the City of Bexley.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That Section 31 of Ordinance No. 47-36, establishing a traffic code of the City of Bexley, Ohio, be amended to read as follows:-

Section 31. STOP BEFORE ENTERING MAIN THOROFARE. a. The following streets are hereby declared to constitute main thoroughfares, for the purpose of this section;

East Broad Street from the mest Corporation line to the East Corporation line.

East Main Street from the mest Corporation line to the East Corporation line.

South Drexel Avenue from East Main Street to East Broad Street.

North Drexel Avenue from East Broad Street to the North Corporation line.

South Cassady Road from East Main Street to East Broad Street.

North Cassady Road from East Broad Street to North Corporation line.

South Parkview Avenue from East Main Street to East Broad Street.

North Parkview Avenue from East Broad Street to the North Corporation line.

College Avenue from East Main Street to the South Corporation line.

South Cassingham Road from East Main Street to East Broad Street.

Dawson Avenue from Main Street to Fair Avenue. V

Remington Road from Main Street to Fair Avenue.

Maryland Avenue from North Parkview Avenue to North Cassady Avenue.

b. Every driver of a vehicle or other conveyance traveling on any street or highway intersecting any main thoroughfare, above designated, shall stop such vehicle or other conveyance, at a place where such street meets the prolongation of the nearest property line of such main thoroughfare, subject, however, to the direction of any traffic control sign or signal or any police officer at such intersection.

c. The Mayor shall erect, or cause to be erected, legible and appropriate signs along the streets and highways intersecting

any main thoroughfare, such signs to contain the legend "Stop, Main Thoroughfare", or other words of similar import, provided, however, no signs shall be required at intersections where traffic signals are maintained.

d. Vehicles traveling on East Broad Street shall have the right of way over vehicles traveling on Drexel Avenue at the intersection of said two main thoroughfares, and legible and appropriate stop signs shall be erected by the Mayor on Drexel Avenue at said intersection.

In the event that traffic signal shall be maintained at said intersection then the foregoing provision shall not be applicable.

Section 2. Said original Section 31, of said ordinance, is hereby repealed.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
