

ORDINANCE NO. 9-40

By Mr. Harlor

Providing for the refunding of payments for water taps on Roosevelt Avenue, as hereinafter listed.

Whereas, in the proceedings for the improvement of Roosevelt Avenue between Broad Street and Fair Avenue it is provided that the cost of installing water taps shall be assessed as part of the cost of said improvement, and

Whereas, through mistake the following named persons have paid to the Division of Water for taps on the lots hereinafter specifically set forth the sum of \$33.00 each, as follows, to-wit:

Whereas, Council is of the opinion that said payments should be refunded to the persons making the same, and that the cost of installing said taps should be assessed against said respective lots as part of the cost of the street improvement, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the sum of \$33.00 be refunded out of the water fund to each of the persons hereinabove listed as having paid the same, and that the cost of installing such taps shall be assessed in the manner heretofore provided by ordinance determining to proceed with the improvement of Roosevelt Avenue between Broad Street and Fair Avenue.

Section 2. That the sum of \$198.00 be and the same is hereby appropriated from the water fund for the above purpose.

Section 3. This ordinance shall take effect and be

in force from and after the earliest period allowed by law.
