OFDINANCE NO. 20-40

To provide for the issue of notes in anticipation of the levy of special assessments and in anticipation of the issuance of bonds in anticipation of the collection of special assessments for the improvement of the alleys herein named by grading and paving, and constructing necessary drains in cooperation with the Work Projects Administration of the United States of America, and declaring an emergency.

Whereas, the council of the city of Bexley has heretofore by proper legislation declared the necessity of improving certain alleys hereinafter named, by grading and paving the same and constructing necessary drains, and

Whereas, this council contemplates the use of \$3000.00 for the purpose of paying the portion of the cost of said improvement, which is to be paid by assessment, and it will require not to exceed \$150.00 to care for interest maturing previous to the receipt of the assessments from which such interest is ultimately to be paid, either upon the bonds or notes hereinafter provided for, making an aggregate amount of \$3150.00, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:
Three-fourths of all members elected thereto concurring:

Section 1. That it is hereby declared necessary to issue the bonds of the City of Bexley in the principal sum of \$3150.00, for the purpose of raising money in anticipation of the collection of special assessments for the improvement of the following described alleys in the city of Bexley, to-wit:

- (a) The first alley south of Astor Avenue from Vernon Road to Roosevelt Avenue.
- (b) The first alley north of Astor Avenue from Remington Road to Vernon Road.
- (c) The first alley south of Main Street from Chelsea Avenue to the first alley east of Chelsea Avenue.
- (d) That part of the alley between Brentwood Road and Bexley Park Road extending westerly from Remington Road a distance of 100 feet.

- (f) The first alley east of Roosevelt Avenue extending from the north lineof Bexley Highlands Amended Addition to the north line of Ardmore Addition No. 2.
- (g) The first alley east of Cassady Road from Maryland Avenue to Ruhl Avenue.

Section 2. That said bonds shall be of the denomination of \$600.00, except one thereof shall be \$750.00, and shall be dated April 1st, 1941; shall bear interest at the rate of 3% per annum, payable semi-annually, on the 1st days of April and October of each year until the principal sum is paid, and shall mature in five annual installments after their issuance.

Section 3. That for the purpose of raising money in anticipation of the levy of special assessments and in anticipation of the issuance of bonds in anticipation of the collection of special assessments for the improvement of the above named alleys—grading and paving, or otherwise improving the same, in accordance with the legislation heretofore passed by the city council with respect thereto, to pay the property owners' shere of the cost and expense of said improvement, it is hereby declared necessary to is ue, and there shall be issued, notes of said city in the amount of \$3150.00, which shall be placed to the credit of the paving funds of said alleys.

Provided, however, that the appropriation hereinabove made for the paving of said alleys is subject to the qualification that interest at the rate of 3% per annum for the period prior the collection of the first installment so to be levied shall be included in said respective amounts, and the amount necessary to pay said interest is hereby appropriated for the payment thereof and for no other purpose and the respective amounts above set forth shall be reduced by the apportioned amounts for the payment of said interest.

Section 4. That such anticipatory notes in the amount aforesaid shall be issued bearing interest at the rate of 3% per annum, payable semi-annually. Such notes shall be dated the 1st day of April, 1940, and shall mature on April 1st, 1941. Such notes shall be executed and delivered in such number and such denominations as may be requested by the purchaser of such notes.

Section 5. Such notes shall be executed by the Mayor and City Auditor and shall bear the seal of the corporation. They shall be payable at the office of the Auditor of the City of Bexley, Ohio; they shall express upon their face the purpose for which they are issued and that they are issued pursuant to this ordinance.

Section 6. All assessments collected for the improvements aforesaid and unexpended balances remaining in the funds after the costs and expenses of said improvements have been paid, shall be applied no the payment of said notes and the interest thereon until both are fully provided for.

Section 7. Said notes shall be first offered to the Sinking Fund Trustees of the city and so many of the same as shall not be taken by said Trustees shall be sold according to law, but for not less than par and accrued interest, and the proceeds from such sale, except any premium and accrued interest thereon (and the amount necrossary for the payment of interest prior to the maturity of said notes), shall be paid into the proper fund and used for the purpose aforesaid and for no other purpose. Any premium and acrued interest (and the amount necessary for the payment of interest prior to their maturity) shall be transferred to the Sinking Fund to be applied in the payment of principal and interest of said notes in the manner provided by law.

Section 8. Said notes hall be the full general obligation of the city, and the full faith, credit and revenue of said city are hereby pledged for the prompt payment of the same. The par value to be received from the sale of the bonds anticipated by said notes and any excess fund resulting from the issuance of said notes shall to the extent necessary, be used only for the retirement of said notes at maturity, together with interest thereon, and is hereby pledged for such purpose.

Section 9. In the event that such assessments are not levied or bonds are not issued to provide a fund for the payment of said notes at maturity, a general tax shall be levied against all of the property in said city for the payment of such notes and the interest thereon.

Section 10. The City Auditor is hereby directed to forward a certified copy of this owninance to the County Auditor.

Section 11. That this ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being that said alleys are in an impassible condition and dangerous to traffic and should be improved without delay, and said ordinance shall go into immediate force and effect.
