By Mr. Betz

Declaring it necessary to improve Charles Street from Euclaire Avenue to Cassingham Road, by grading and paving the roadway thereof, constructing curbs and gutters, sidewalks, the necessary drains, water main and water connections in cooperation with Work Projects Administration, and declaring an emergency.

Whereas, petitions have been filed with Council by the owners of *hrse-fourths , or more, in interest, and the owners of more than 60% of the foot frontage of property bounding and abutting upon Charles Street from Euclaire Avenue to Cassingham Road, petitioning in writing for the improvement of said Charles Street between said points, in the manner hereinafter described, in cooperation with the Work Projects Administration of the United States Government, therein agreeing and consenting that the entire cost of said improvement, except that portion thereof to be borne by said Work Projects Administration, and except the cost of said water main and water taps and excepting 2% of the balance and cost of intersections, may be assessed and collected in equal annual installments proportioned to the whole assessment in the manner which may be fixed by Councl, and further therein consenting and requesting that said assessments be levied and collected without reference to the value of the property of said petitioners, and therein waiving all the benefits of the provisions of the General Code of Ohio limiting the assessments to thirty-three and one-third per cent of the value of the property assessed for any and all purposes within the period of five years; and further waiving all benefits of the provisions of the General Code providing for the service and publication of any and all notices of the proceedings for the construction of said improvement and for the making and levying of the assessments for said improvements, NOW, THEREFORE:

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BECLEY, STATE OF OHIO: Three-fourths of all members elected thereto concurring:

Section 1. That it is necessary to improve Charles

Street from Euclaire Avenue to Cassingham Road, by grading and paving the roadway thereof with concrete foundation with bituminous concrete surface, constructing concrete curbs and gutters, the necessary drains to furnish drainage for said improvement, sidewalks on each side thereof, and constructing a water main, and installing water taps in accordance with the plans, specifications, estimates and profiles of the proposed improvement heretofore prepared by the engineers and now on file in the office of the Mayor, which plans, specifications, estimates and profiles are hereby approved.

Section 2. That whereas, the Mork Projects Administration of the Public Works of the United States has proposed and agreed to furnish all labor in the making of said improvement and a portion of the materials necessary therefor, and to make and perform said improvement, on condition that the City of Bexley shall furnish the balance of said materials and equipment and other direct costs, including engineering services, in accordance with the Work Progress Administration Form Mo. 301, now on file with the Mayor, said improvement shall be made in cooperation with said Work Projects Administration, or other governmental agency, in accordance with said proposal and agreement.

Section 3. That the grade of said street and curbs as improved shall be as shown by the engineers' plans and profiles, which are made a part hereof, and which are on file in the office of the Mayor.

Section 4. That in accordance with said petition the entire cost of said improvement, except that portion thereof to be borne by said Work Projects Administration and excepting the cost of said water main and water connections, and excepting 20% of the balance which 20% is in excess of 2% of the balance and the cost of intersections, shall be assessed in proportion to the

benefits which may result from the improvement upon the following described lots and lands, to-wit: all lots and lands bounding and abutting upon said proposed improvement, which said lots and lands are hereby determined to be specially benefitted by said improvement, in an amount not less than the cost thereof, and the cost of said improvement shall include the expense of the preliminary and other surveys, and of the printing and publishing of notices, resolutions and ordinances required, the serving of said notices, the cost of construction of deferred assessments, and of all other necessary expenditures, as provided in said proposal and agreement of said work Projects Administration.

paid in 5 annual installments with interest on deferred payments at the same rate as shall be borne by the bonds to be issued in anticipation of the collection thereof, provided that the owner of any property assessed may at his option pay such assessment in cash within thirty days after the passage of the assessing ordinance.

Section 6. That the cost of installing said water taps shall be paid by the city from the water fund, and said fund shall be reimbursed for the cost of installing said water taps by a charge to the respective property owners at the time they shall connect with the same.

Section 7. That the bonds of the City of BexLey shall be issued in anticipation of the collection of the assessments by installments and in an amount equal thereto, and notes of said city shall be issued in anticipation of the issuance of such bonds.

section 8. This resolution is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being that said street is in a condition dangerous to public traffic and should be immediately improved, and said resolution shall go into immediate force and effect.
