

ORDINANCE NO. 25-41

To provide for refuse collection and disposal.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. For the purpose of this ordinance the word "rubbish" shall be held and considered to include all household waste matter such as paper, straw, excelsior, rags, wearing apparel, corn husks and cobs, bottles, tin cans, ashes, food containers, grass trimmings, trimmings from shrubs and trees, and other waste matters accumulating about dwellings. Waste materials accumulated in the construction, remodeling or repairing of buildings is excluded in the definition of rubbish.

Section 2. It shall be the duty of every tenant, lessee or occupant of every dwelling in the City of Bexley to provide or cause to be provided receptacles for the deposit of all rubbish in said dwelling, or on the premises in the connection therewith. Such receptacles shall be made of wood or metal, and if water tight, shall be provided with water proof cover, the capacity not to exceed that of an ordinary barrel, and the dimensions and weight of container such that one man can conveniently handle same. All containers of rubbish or ashes must be constructed so as to exclude an excessive amount of water.

Section 3. Where premises abut on an alley an entrance must be provided thereto, and such rubbish receptacles shall be placed on inside of rear lot line adjacent to said entrance. Where premises do not abut on an alley the receptacles shall be placed not more than 30 feet distant from the rear of the dwelling so that collection may be conveniently made from the front. In cases where it is impracticable to make collections from locations above mentioned, then receptacles shall be placed at such point as may be designated by the Mayor or his representative. Furniture, barrels, boxes, and other articles too bulky to enter approved containers shall be placed at the collection point as rubbish and ash containers.

Section 4. Every person, firm or corporation responsible for the presence in any street, alley or public place within the City of Bexley of earth, gravel, brick, mortar, stone, wood, lime, plaster, cement or other refuse from the repair, construction or demolition of buildings, sewers, streets, or other improvements, shall remove or cause the same to be removed forthwith from such alley or public place.

Section 5. It shall be unlawful to throw or deposit any rubbish, or to maintain any receptacle for rubbish in or upon any street, alley or public place in the City. Provided, however, the Mayor or his representative, may authorize the placing of receptacles in front of premises between the curb line and property line, for collection of rubbish, such receptacles in no case to remain on the street more than twelve consecutive hours.

Section 6. The Mayor shall, through the Department of Public Service, collect and dispose of all rubbish accumulating on premises used for dwelling purposes in the City of Bexley, provided, however, that he shall not be required to remove such rubbish or ashes if the foregoing provisions as to receptacles and deposit of refuse have not been complied with. Provided further that nothing herein shall prevent an owner, tenant, lessee or occupant of premises from removing or employing others to remove such rubbish from the premises owned or occupied by him; but any person so employed to remove any rubbish shall register his name and address with the Chief of Police before entering upon any such employment.

Section 7. It shall be unlawful for any person, firm or corporation, without having first obtained the written consent of the owner, tenant, lessee, or occupant of any dwelling to remove or carry away any rubbish from any rubbish receptacle unless he shall at the same time take the rubbish contained in such receptacle or receptacles, and no portion thereof or any part thereof shall be dumped or deposited within the city limits except at such place or places as shall be designated by the Mayor for that

purpose.

Section 8. Any person, or persons, violating any of the provisions of this ordinance shall upon conviction thereof be fined not more than \$25.00, together with the costs of prosecution.

Section 9. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
