

ORDINANCE NO. 28-45

Cancelling Bonds of Trustees of the Sinking Fund.

Whereas, Herbert Green and Frank Cain, did on or about the tenth day of January, 1942, and H. C. Gochenbach did on or about the 2nd day of January, 1943, execute their respective bonds to the City of Bexley, Ohio, for the faithful performance of the duties of office of Sinking Fund Trustees, City of Bexley, Ohio, and upon which bonds the Travelers Indemnity Company is surety, which said bonds are each in the principal sum of \$500.00 and are numbered 20684, 20682 and 37024, respectively and, Whereas, under the provisions of Section 2295-14 of the General Code of Ohio, and of Section 41 of the Charter of the City of Bexley, Ohio, and of Ordinance No. 6-43 of the City of Bexley, passed on the 23rd day of March, 1943, the Board of Sinking Fund Trustees of said City of Bexley was abolished by reason of the fact that all outstanding bonds of said City issued previous to January 1, 1942, had been fully paid and said official bonds are no longer required, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That by reason of the abolishment of the Board of Sinking Fund Trustees of the City of Bexley, as hereinabove recited, the official bonds of said Herbert Green, Frank Cain and H. C. Gochenbach as Sinking Fund Trustees, being bonds numbered 20684, 20682 and 37024, respectively, each in the principal sum of \$500.00 and upon which the Travelers Indemnity Company is surety, be and the same are hereby cancelled, except for any fault that may have occurred upon said bonds or any thereof prior to the passage of Ordinance No. 6-43, abolishing said Board of Trustees of the Sinking Fund, to-wit: On or before March 23, 1943.

Section 2. That the Clerk be and is hereby directed to notify each principal and surety upon said respective bonds of the cancellation thereof and to receive any refunds that may be due

upon the cancellation of said bonds.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
