Final Resolution

Adopting plans; proposing to co-operate; requesting Director to proceed;

MT. Altmaier moved the adoption of the following resolution:
WHEREAS, At a meeting of the city council of Bexley, Ohio,
held in the office of the council of said city, on the 2nd day of
August, 1944, a quorum being present, the improvement of State
Highways Nos. 1 and 49 and Temporary U. S. Route No. 40 (Main
Street), under the provisions of section 1178 and related sections
inclusive of the General Code of Ohio, came on for further consideration; said portion of road as described in the preliminary application of this council to the state highway director of Ohio, on the
2nd day of August, 1944, being as follows:

Beginning at the east end of the bridge over Alum Creek in the city of Bexley; thence East along East Main Street to the East corporation line of the city of Bexley and there terminate, being in all a distance of approximately 0.977 mile.

WHEREAS, The state highway director has approved said application and has caused a map of the above described section to be made in outline and profile.

WHEREAS. The state highway director has caused to be made plans and specifications and an estimate of cost and expense for improve the above described highway, and has transmitted the same to this council, with the certificate of his approval indorsed thereon; and

whereas, Funds for the payment of the estimated cost of said improvement other than the proportion and share of said cost that is to be borne by the State have become available, as to which funds the city auditor has made a certificate, now on file with this council and here recorded as follows:

Thereby certify that the money, to-wit: \$20,350.00 required for the payment of the cost other than that part thereof assumed by the State for the improvement designated as:

Part 1 - Franklin - 1 - Bexley (Part)

Temporary U. S. Route 40 (Main Street) Type T-35 (1944)

is in the treasury to the credit of, or has been levied, placed on the duplicate and in process of collection for the state and city road improvement fund and not appropriated for any other purpose; or is being obtained by sale of bonds of said city issued on account of said improvement, which bonds are sold and in process of delivery.

I further certify that this certificate was made, sealed and filed with the city council of Bexley, Ohio, before said city council passed the final resolution in connection with the within described project; and that this certificate was forthwith recorded in the record of proceedings of said city council, namely: council's journal, volume M, at page 171.

RESOLVED, That this council is still of the opinion the proposed work on the above described section should be constructed; and that the city should co-operate upon the basis set forth in their proposal;

RESOLVED. That the sum of Twenty Thousand Three Hundred Fifty ----- 00/100 Dollars (\$20,350.00), being \$23,650.00 less than the total estimated cost and expense of the construction of said improvement which total estimated cost and expense is Forty Four Thousand ----- 00/100 Dollars (\$44,000.00), be and the same is hereby appropriated, of which sum \$10,350.00 is appropriated from the Street Maintenance and Repair Gasoline Tax Fund, and \$10,000.00 from the Street Maintenance and Repair Motor Vehicle License Fund, for improving under the provisions of said law, the highway described above; and the city auditor is hereby authorized and directed to issue his order on the city treasurer for said sum or part thereof upon the requisition of the state highway director, to pay the cost and expense of said improvement, as the same may become due under provisions of said law. We hereby agree to assume in the first instance the share of the cost and expense over and above the amount to be paid by the State, and guarantee the state highway director that such money shall be available at such time or times as it may be needed in the construction of said highway.

RESOLVED, That this council hereby requests the state high-way director to proceed with the aforesaid proposed work.
