Accepting the deed of gift of Miss May Elizabeth Cook of the certain pieces of art hereinafter listed.

Whereas, Miss May Elizabeth Cook of the City of Columbus, Ohio, has executed her deed of gift bearing date of the 27th day of January, 1944, conveying to the City of Bexley the following pieces of art and personal property absolutely and without reservation of any kind, but with the suggestion that said articles be placed in the Jeffrey House heretofore transferred to the City of Bexley by Robert H. Jeffrey and Mary Allen Jeffrey for such time as the City of Bexley may deem it appropriate, said pieces of art and personal property being more particularly described as follows, to-wit:

- 1. "Spirit of Flight" being a relief in plaster approximately 10' x 6' in size;
- 2. "Repos" being a plaster statue in the round approximately life-size;
- 3. "Radar" being a bas-relief approximately 3 x 2! in size;
- 4. "Boy with Turtle" being a life-size statue in the round in marble.

The foregoing articles are the original work of Miss Cook.
Also the following rticles:

- 5. A marble model of Michelangelo's "Day";
- 6. A photograph of Michelangelo's "David";
- 7. One Mahogany Bookcase.

And, whereas, Council is of the opinion that said gift should be accepted by the City in the interest of the public culture, education and entertainment.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the deed of gift of the above listed objects of art by Miss May Elizabeth Cook be and the same is hereby accepted, and it is directed that said pieces of art be properly placed and exhibited in the Jeffrey House until further ordered

by Council.

Section 2. Be it further ordain and way or be and is hereby authorized and directed to the to Miss Cook the appreciation and thanks of the Council for her generous gift.

Section 3. This ordinance shall take effect and be in force from and after the estalest period allowed by law.
