To amend Section 3 (a) of Ordinance No. 93-31, establishing administrative departments for the City or Bexley, as amended by Ordinance No. 3-33, passed January 24, 1955, and declaring an emergency.

ME IT ORDAINED BY THE COUNCIL OF THE CITY OF BENLEY, STATE OF OHIO:

Section 1. That Section 3 (a) of Ordinance No. 93-31, establishing administrative departments for the City of Bemley, passed December 22nd, 1931, be and the same is hereby amended to read as follows:

Section 3 (a). The Division of Police, or Police Department shall be composed of the following officers and other members who shall receive ine respective salaries hereinafter provided.

- (1) A Chief of Police who shall be appointed by the Layor from names or lisks submitted by the Civil Service Commission in accordance with law; he shall receive a salary of \$2772.00 per annum, payable semi-monthly.
- (2) Two Police Sergeants who shall be appointed by the Mayor from hames or lists submitted by the Civil Service Commission in accordance with law; each shall receive a salary of \$2310.00 per annum, payable semi-monthly..
- (3) Not to exceed 12 Patrolmen, who shall be appointed by the Mayor from lists submitted by the Civil Service Commission in accordance with law; the salarles of said patrolmen shall be dependent upon their length of service, and shall be as follows, towit:

For the first year \$1848.00 per annu payable semi-monthly, For the second year and thereafter, \$2178.00 per annum, payable semi-monthly.

Provided, however, such persons as have been continuously in the service of the municipality for two years next preceding the first day of January, 1932, may be appointed to this Department to serve until discharged, reduced, promoted or transferred in accordance with the provisions of the Charter. The duties of the Chief and other members of the Department shall be as prescribed by the Charter and the statutes of Ohio, or by ordinance of Council hereafter enacted. They shall also serve notices and enforce the rules and regulations of the Beard of Health and other Boards, as directed by the Mayor, and shall maintain and keep in good condition all police automobiles, motorcycles, raios, and other equipment used by this Department. They shall also perform such duties in connection with

the Fire Department as may be required by the Layor or Chief of the Fire Department until otherwise provided by ordinance.

Section 2. That said Section 3 (a) of Ordinance 93-31, Ordinance No. 3-55, and all other ordinances in conflict herewith, be and the same are hereby repealed.

Section 3. This ordinance is an emergency ordinance and is necessary for the immediate preservation of the public health and safety, and shall go into immediate effect.
