

## ORDINANCE NO. 26-45

To appropriate property for the location and construction of buildings and structures required for municipal offices and for the use of the departments of public service and public safety, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Two-thirds of all members elected thereto concurring:

Section 1. That the following described property in fee simple be, and the same is hereby appropriated to public use for the purpose of locating and constructing buildings and structures required for municipal offices and for the use of the departments of public service and public safety, to-wit:

Situate in the County of Franklin, in the State of Ohio and in the City of Bexley, and bounded and described as follows:

Being a strip of ground forty (40) feet wide off of the west side of the following described premises and having a frontage of forty (40) feet on the north side of East Main Street, and extending northwardly of uniform width two hundred ten (210) feet, more or less, to the north line of said premises, to-wit:

Being a part of Half Section 20, Township 5, Range 22, Refugee Lands, beginning at a stone at the southeast corner of a parcel of ground containing two acres, more or less, which was conveyed by William Stout and wife to Littleton R. Gray, by deed dated January 8, 1848, and of record in Deed Book No. 36, page 427, of the Deed Records of Franklin County, Ohio, said stone being in the southeast corner of the premises hereby described; thence westerly on the north line of East Main Street, formerly a National Road, 158 feet, more or less, to a stone; thence northerly 210 feet, more or less, to a stone; thence easterly 158 feet, more or less, to a stone; thence southerly 210 feet, more or less, to the beginning, containing three-fourths (3/4) of an acre, more or less, and being the same premises which were set off to May E. Mehring by proceedings in partition of the Court of Common Pleas of Franklin County, Ohio, in the case of Peter H. Wolf, et al., vs. May E. Mehring, et al., and recorded in Complete Records No. 43, page 117, in said court.

Section 2. That the solicitor be, and he is hereby authorized and directed to apply to a court of competent jurisdiction to have a jury impaneled to make inquiry into and assess

the compensation to be paid for such property.

Section 3. That the costs and expenses of said appropriation be paid out of the General Fund.

Section 4. That this ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being that said city is without adequate facilities for housing its various departments of government, and said ordinance shall go into full force and effect upon the passage thereof.
