

ORDINANCE NO. 18-46

To provide for the removal of dead trees from the streets and other public property in the City of Bexley, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor and Auditor be, and they are hereby authorized to enter into a contract, after advertisement according to law, for the removal of dead trees and stumps located on the streets and public property in the City of Bexley, estimated at approximately 302 in number, and filling with good soil and leveling to the existing parkstrip or surrounding grade the holes or excavations caused by the removal of said trees and stumps, according to the specifications which are now on file in the Mayor's office, which are hereby approved.

Section 2. That the contractors shall be required to proceed diligently to remove all such dead, or diseased trees, and stumps, as shall be marked and designated for that purpose by the Mayor or superintendent of parks, which trees are approximately the number hereinabove estimated, and shall exercise care not to damage streets, sidewalks, curbs, wires, cables or other utilities or properties, private or public, and shall complete such work subject to the approval of the engineers of the city.

Section 3. That said contract shall provide that the contractor shall carry insurance for the protection of the city and public in not less than the following amounts, in a company or companies to the satisfaction of the Mayor, to-wit: Public Liability Insurance in the sum of not less than 10-20 thousand dollars; Property Damage Insurance in the sum of 5-50 thousand dollar limits; and Owners Protective Policy to be issued in the name of the City of Bexley, Ohio, covering Public Liability

Insurance in the sum of not less than 10-20 thousand dollar limits and Property Damage in not less than 5-50 thousand dollar limits. Also said contractor shall be required to be insured under the Workman's Compensation laws even though he may employ less than three men.

Section 4. The sum of \$ _____ is hereby appropriated from the _____ Fund for the foregoing purposes.

Section 5. This ordinance is an emergency measure, necessary for the immediate preservation of the public health and safety, said emergency being that many trees on public grounds are dead, or diseased, and in a dangerous condition, and should be removed at once, for which reason this ordinance shall go into immediate force and effect.
