

## ORDINANCE NO. 51-46

Providing for special building permits to the Capital University to place, erect, construct and maintain temporary dwelling and dormitory accommodations for G. I. students and families, in co-operation with the Federal Public Housing Authority, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEILEY, STATE OF OHIO:

Section 1. That special permission is hereby granted to the Capital University to place, erect, construct and maintain on its campus, temporary dwelling accommodations, consisting of two-family dwelling units accommodating not to exceed eight families per unit, and dormitory accommodations consisting of five units accommodating not to exceed twenty-four single persons per unit, restricted to G. I. students enrolled under the G. I. Bill of Rights, said dormitory accommodations to be occupied only by single male students; which said accommodations are to be furnished by the Federal Public Housing Authority through utilization or re-utilization of existing structures, equipment, materials or other facilities available, or made available, to it for the purpose of carrying out the provisions of Title V of the Lanham Act (Public Law 849, 76th Congress, as amended) and in accordance with the terms of the contract between said University and the Federal Public Housing Authority, under date of \_\_\_\_\_, 1946, and especially insofar as the same imposes upon the University the duty to provide all proper sanitary and health installations and utilities for the servicing thereof.

Said family dwelling accommodations shall consist of two separate units or buildings, located at the northwest and southwest corners, respectively, of the Athletic field of the University.

Said single, or bachelor, accommodations shall consist of five separate units or buildings, to be located as follows: Two thereof on the campus on the east side of Pleasant Ridge Avenue and north of Mound Street, and shall be placed perpendi-

cular to Pleasant Ridge Avenue, and not parallel thereto; two thereof shall be located on the campus west of the girls' dormitory, and shall be placed perpendicular to Mound Street; and one thereof shall be located on the campus at the rear of President's home.

Section 2. That the permission hereby granted is temporary only, and said temporary dwelling and dormitory accommodations shall be removed by said University not later than two years after the termination of the emergency declared by the President of the United States to exist on September 8, 1939, and the same shall be removed at such earlier date as the same shall cease to be used or occupied by students under said G. I. Bill of Rights.


Section 3. That the Superintendent of Building be, and he is hereby authorized and directed, upon application to him by said Capital University, to issue special building permits authorizing said Capital University, in co-operation the said Federal Public Housing Authority, to place, erect, construct and maintain said temporary dwelling and dormitory accommodations at the above designated locations, which permits shall state upon the face thereof that same are issued subject to and conditioned upon the provisions of this ordinance and the provisions of said contract with said FPHA, insofar as the same do not conflict with the provisions of this ordinance. In locating said units, the provisions of Ordinance No. 456, insofar as the same relates to set-back lines, shall be observed as far as practicable; provided, however, the family units at the northwest corner of the athletic field shall be not less than eight feet from the rear property line of the adjoining residence.

Section 4. Ordinance No. 16-46, passed April 23, 1946, is hereby repealed.

Section 5. This ordinance is an emergency ordinance, necessary for the immediate preservation of the public peace, health and safety, said emergency being that the G. I. students


of said Capital University are without proper dwelling and dormitory accommodations, and the same shall go into immediate force and effect.


Reappropriating moneys within the appropriation for the Recreation Fund in the General Fund.
