## ORDINAL NO. 12-48

Providing for a traffic control light at the intersection of Mound Street and Montrose Avenue, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor be and he is hereby authorized to install a traffic control light at the intersection of Mound Street and Montrose Avenue, which said light shall be equipped to exhibit successively, one at a time, red, green and yellow lights, and have printed on, or attached thereto, the words "School Light" in letters not less than 3 inches in height, and shall be so constructed that the same may be controlled by means of a switch or other devise to be operated at or near said intersection.

Said light shall be operated only at the hours when school children are accustomed to cross said above named streets on their way to and from the school building at Main Street and Montrose Avenue, and only at such times as there is present at said intersection a school patrol to assist in controlling traffic and enabling the school children to safely cross said intersection in accordance with said traffic signal light.

At all times when said traffic control light is in operation all persons, pedestrians, and operators of motor vehicles, or other vehicles, shall conduct themselves in accordance with, and be controlled by, the provisions of the Uniform Traffic Act of Ohio.

Section 2. Such persons as may be designated by the Board of Education of the Bexley City school district for that purpose is hereby authorized and empowered to switch said traffic signal light on and off at the times hereinabove provided for the operation of the same.

Section 3. The sum of \$900.00 is hereby appropriated from the general fund for the cost of such installation.

Section 4. Any person who shall be guilty of violating any of the provisions of this ordinance shall, upon conviction thereof, be fined not less than \$5.00 nor more than \$50.00, together with the

costs of prosecution.

Section 5. This ordinance is an emergency measure, necessary for the localate preservation of the public peace, health and safety, said emergency being that a dangerous traffic condition exists at said intersection, and said ordinance shall go into immediate force and effect.
