RESOLUTION NO. 7-49

FINAL RESOLUTION

Adopting plans; Proposing to co-operate; Requesting Director to proceed; (Sections 1178-45 and 1178-42 G. C.)

Mr. Arthur C. Helmbrecht moved the adoption of the following resolution:

WHEREAS, At a meeting of the city council of Bexley, Ohio, held in the office of the council of said city, on the 19th day of July, 1949, a quorum being present, the improvement of U. S. Route No. 40, under the provisions of section 1178 and related sections inclusive of the General Code of Ohio, came on for further consideration; said portion of road as described in the preliminary application of this council to the state highway director of Ohio, on the 24th day of May, 1949, being as follows: Beginning at the intersection of Broad Street and Drexel Avenue; thence southerly along Drexel Avenue (U. S. Route No. 40) to Main Street, a distance of 0.808 mile.

whereas, The city council of Bexley, Ohio, in said preliminary application, proposes to cooperate with the state highway director of Ohio in the constructing, reconstructing, improvement, widening, maintenance, repair of U.S. Route No. 40, by assuming and contributing a lump sum of Eleven Thousand Three Hundred Thirty Seven-----00/100 Dollars (\$11,337.00) inclusive of the cost of engineering, preliminary contingencies and other incidental expenses.

WHEREAS, The state highway director has approved said application and has caused a map of the above described Section to be made in outline and profile.

WHEREAS, The State highway director has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway, and has transmitted the same to this council, with the certificate of his approval indorsed thereon; and

WHEREAS, Funds for the payment of the estimated cost of said improvement other than the proportion and share of said cost that is to
be borne by the State of Ohio, has become available, as to which funds
the city auditor has made a certificate, now on file with this council

and here recorded as follows:

I hereby certify that the money, to-wit: \$11,337.00 required for the payment of the cost other than that part thereof assumed by the State for the improvement designated as: Franklin - U. S. Route No. 40 - (15.96 - 16.09) Type - T-35 is in the treasury to the credit of, or has been levied, placed on the duplicate and in process of collection for the state and city road improvement fund and not appropriated for any other purpose; or is being obtained by sale of bonds of said city issued on account of said improvement, which bonds are sold and in process of delivery.

I further certify that this certificate was made, sealed and filed with the city council of Bexley, Ohio, before said city council passed the final resolution in connection with the within described project; and that this certificate was forthwith recorded in the record of proceedings of said city council, namely, council's journal, volume _____, at page _____.

WHEREAS, This council desires the state highway director to proceed with the aforesaid work; Therefore Be it

RESOLVED, That the section of highway above described be improved under the provisions of aforesaid law. That said work be done under the charge, care and superintendence of the state highway director and that said maps, plans, specifications and estimates for this improvement as approved by the state highway director, are hereby approved and adopted by this council.

RESOLVED, That this council is still of the opinion the proposed work on the above described section should be constructed; and that the city should co-operate upon the basis set forth in their proposal:

RESOLVED, That the lump sum of Eleven Thousand Three Hundred Thirty Seven-----00/100 Dollars (\$11,337.00) be and the same is hereby appropriated for the improving under the provisions of said

law, the highway described above; and the city auditor is hereby his order authorized and directed to issue on the city treasurer for said sum or part thereof upon the requisition of the state highway director, to pay the cost and expense of said improvement, as the same may become due under provisions of said law. We hereby agree to assume in the first instance the share of the cost and expense over and above the amount to be paid by the State of Ohio and guarantee the state highway director that such money shall be available at such time or times as it may be needed in the construction of said highway.

RESOLVED, That this council hereby requests the state high-way director to proceed with the aforesaid proposed work.

BE IT FURTHER RESOLVED, That the clerk of this council be, and he is hereby directed to transmit to the state highway director a certified copy of these resolutions.
