

ORDINANCE NO. 16-49

By Mr.

To levy special assessments for the construction of sidewalks on the streets and highways hereinafter named.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of constructing sidewalks on the following described streets and highways in the City of Bexley between the following points, to-wit:

- Remington Road, Powell Avenue to Broad Street
- Montrose Avenue, Main Street to Livingston Avenue
- Remington Road, Main Street to Livingston Avenue
- Cassingham Road, Main Street to Livingston Avenue
- Stanwood Road, Broad Street to Rural Avenue
- Remington Road, Broad Street to Maryland Avenue
- Astor Avenue, College Avenue to Pleasant Ridge Avenue
- Vernon Road, Main Street to Livingston Avenue
- Euclaire Avenue, Main Street to Livingston Avenue,

in the aggregate amount of \$9,396.30 as reported to this Council by the Mayor and the Engineers, notice of the filing of which assessment has been given as required by law, be, and the same is hereby adopted and confirmed, and that there be and is hereby levied and assessed upon the lots and lands bounding and fronting upon said improvement the several amounts reported as aforesaid, which assessments, together with the description of said lots and lands, are now on file in the office of the Clerk of this Council, and which assessments represent the cost and expense of said improvement to each lot, and are not in excess of the special benefits to said property, and are not in excess of any statutory limitation, said assessments, together with the description of said lots and lands, are as follows, to-wit:

Section 2. That the total assessment against each lot or parcel of land shall be payable in cash within thirty days from and after the passage of this Ordinance, or, at the option of the owner, in two equal installments with interest at the rate of 3%. All cash payments shall be made to the Auditor of the said City of Bexley. All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the Clerk of this Council to the County Auditor, as provided by law to be by him placed on the tax duplicate, together with a penalty of 5% thereon, and by him collected together with said penalty, as other taxes are collected.

Section 3. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
