ORDINANCE NO. 17-49

Providing for the construction of a Garage and Storage
Building in the City of Bexley, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:
Three-fourths of all members elected thereto concurring:

Section 1. That, whereas, it is necessary to construct a Garage and Storage Building for the use of the various departments of the City of Bexley, and the Planning Commission has, by resolution duly adopted, approved the plans and specifications for such building heretofore prepared by Inscho, Brand and Inscho, Architects, employed by the City for that purpose, and has approved the location of such building on grounds heretofore acquired at, and adjacent to, No. 2242 East Main Street, in said City, and has approved the size, height, style and general appearance of such building, it is hereby determined to proceed with the construction of such Garage and Storage Building, and necessary appurtenances, on said premises at No. 2242 East Main Street, and adjacent thereto, all in accordance with the plans, specifications, profiles and estimates heretofore prepared by said architects and on file in the Office of the Mayor, which said plans, specifications, profiles and estimates are hereby approved.

Section 2. That said construction shall be under the supervision of the Mayor, and of said architects in accordance with the provisions of their contract heretofore entered into for architectural services.

Section 3. That the sum of \$175,000.00 is hereby appropriated from the General Fund for the payment of the cost of said construction and the supervision thereor by said architects.

Section 4. That the Mayor and Auditor be, and they hereby are, authorized to enter into a contract, or contracts, for the construction of said building, after advertisement according to law. That such advertisement shall call for bids on said project as an entirety, and for separate bids on the Garage Building proper and on the Storage Building, respectively, reserving the right to accept or reject any or all bids, and to enter into contracts for such of said construction for which

bids may be accepted.

Section 5. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being that the present garage and storage facilities are entirely inadequate and have become defective and dangerous to said employees, and said ordinance shall go into effect upon the passage thereof.
