Accepting deeds of persons hereinafter named for public street purposes, to-wit:

To open and extend Merkle Road.

WHEREAS, the following named persons have executed their certain warranty deeds to the City of Bexley for public street purposes, to-wit:

The opening and extending of Merkle Road, which deeds and the premises therein conveyed are described as follows, to-wit:

1. The deed of Edward J. Merkle and Daisy B. Merkle, his wife, bearing date of January 26, 1950, granting and conveying the following described premises in the City of Bexley for public street purposes, for opening and extending Merkle Road, to-wit:

Being an undivided two-thirds (2/3) interest in a strip of land twenty feet in width off of the west side of the following described tract, to-wit:

Beginning at a point in the south line of East Broad Street at the northeast corner of Robert Weiler's Subdivision No. 1, as the same is shown of record in Plat Book 21, page 26, Recorder's Office, Franklin County, Ohio; thence with the south line of East Broad Street, N. 78° E. 389.02 ft. to the intersection of the south line with the west line of Gould Road; thence with the west line of Gould Road, S. 0° 08-2' E. 1537.71 ft. to a point in said west line at its intersection with the north line of Ardmore Addition, as the same is shown of record in Plat Book 11, page 7, Recorder's Office, Franklin County, Ohio; thence with the north line of said subdivision, S. 89019' W. 383 ft. to a point at the southeast corner of Robert Weiler's Subdivision No. 1, above mentioned; thence with the east line of said subdivision, N. 0° 03' W. 1460.46 ft. to the place of beginning, containing 13.14 Acres.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That said above respective deeds of Edward J.

Merkle and Daisy B. Merkle, his wife, and said John M. Doolan and Aileen C. Doolan, his wife, conveying to said City of Bexley the premises hereinabove described for street purposes, for the opening and extending of Merkle Road, be and the same are hereby accepted, and the Clerk of Council is hereby directed to certify upon said respective deeds the acceptance thereof, and to file same for record in the Recorder's Office of Franklin County, Ohio, and that he furnish a certified copy of each deed to the County Auditor of Franklin County, Ohio.
