Company in full payment of the cost and expense of the improvement
of Ruhl Avenue between Northview Drive and Cassady Road by constructing a water main therein.

MHEREAS, Council did, by Ordinance No. 25-48, duly adopted September 14, 1948, determine to proceed with the improvement of Ruhl Avenue between Northview Drive and Cassady Road, by constructing a water main therein, the entire cost whereof, less 2%, and the cost of intersections were determined to be assessed in proportion to benefits upon the benefitted lots and lands; and,

WHEREAS, said improvement was completed on or about the 31st day of December, 1948, the cost whereof, which was to be assessed against said abutting lots and lands, amounts, with interest, to said date, to the sum of \$3,888.92; and,

whereas, the Bexley Woods Company, then being the owner of all lots and land bounding and abutting upon said improvement, elected to pay said entire sum so to be assessed in one lump sum, and requested that the amount of said proposed assessment be determined so that said company could make the immediate payment thereof, and whereas a submission of said bill was unduly delayed until the month of May, 1950, rendering it impossible for said company to make payment, although being ready and able at all times so to do; and,

WHEREAS, said company did, on May 11, 1950, tender to the City its check in the sum of \$3,888.92 in full payment of said proposed assessment, now therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO,

Section 1. That the check of said The Bexley Woods Company, in the said sum of \$5,888.92 be accepted in full payment of the amount heretofore determined to be assessed against the lots and lands bounding and abutting upon said improvment of Ruhl Avenue, by constructing said water main, and that said money be applied to the payment of the Ruhl Avenue water main improvement note heretofore

issued in anticipation of the levy and collection of special assessments for said improvements.

Section 2. This resolution shall take effect and be in force from and after the earliest period allowed by law.
