ORDINANCE NO. 17-50

To provide for the issue of notes in anticipation of the levy of special assements and in anticipation of the issuance of bonds in anticipation of the collection of special assessments for the improvement of Merkle Road from Powell Avenue to East Broad Street, and declaring an emergency.

fore by proper legislation declared the necessity of improving Merkle Road from Powell Avenue to East Broad Street, by grading and paving the roadway thereof with concrete base, with bituminous surface, constructing concrete carbs and gutters, necessary drains to provide drainage for said improvement, a six-inch water main with necessary water taps, and constructing sidewalks on both sides thereof, and,

METREAS, the Council contemplates the use of \$69,000.00 for the purpose of paying the portion of the cost of said improvement, which is to be paid by assessments which amount will also care for interest maturing previous to the receipt of the assessments from which such interest is ultimately to be paid, either upon the bonds or notes, NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO: Three-fourths of all members elected thereto concurring:

Section 1. That it is hereby declared necessary to issue the bonds of the City of Bexley in the principal sum of \$69,000.00 for the purpose of raising money in anticipation of the collection of special assessments for the manner hereinabove described.

Section 2. That said bonds shall be of the denomination of \$1,000.00, and shall be dated approximately June 1, 1951, they shall bear interest at the rate of 2% per annum, payable semiannually, on the first days of June and December of each year until the principal sum is paid, and shall mature in nine annual installments after their issuance.

Section 3. That for the purpose of raising money in anticipation of the levy of special assessments and in anticipation of the issuance of bonds in anticipation of the collection of special assessments for the improvement of Merkle Road from Powell Avenue to East Broad Street in the manner hereinabove described, and in accordance with the legislation heretofore passed by the City Council with respect thereto, to pay the property owners' share of the cost and expense of said improvement, it is hereby declared necessary to issue, and there shall be issued, notes of the City in the amount of \$69,000.00, which shall be placed to the credit of the improvement fund for said Merkle Road from Powell Avenue to East Broad Street.

Provided, however, that the appropriation hereinabove made for said improvements is subject to the qualification that interest at the rate of 2% per annum for the period prior to the collection of the first installment so to be levied shall be included in said respective amounts, and the amount necessary to pay such interest is hereby appropriated for the payment thereof and for no other purpose, and the respective amounts above set forth shall be reduced by the apportioned amounts for the payment of said interest.

Section 4. That such anticipatory notes in the amounts aforesaid shall be issued bearing interest at the rate of 2% per annum, payable semiannually, such notes shall be dated the 1st day of June, 1950, and shall mature on June 1, 1951. Such notes shall be executed and delivered in such manner and such denominations as may be requested by the purchaser of such notes.

Section 5. Such notes shall be executed by the Mayor and City Auditor and shall bear the seal of the corporation. They shall be payable a: the office of the Auditor in the City of Bexley, Ohio; they shall express upon their face the purpose for which they are issued and that they are issued pursuant to this ordinance.

Section 6. All assessments collected for the improvements

aforesaid and unexpended balances remaining in the funds after the costs and expenses of said improvements have been paid, shall be applied to the payment of said notes and the interest thereon until both are fully provided for.

Auditor in his capacity as City Treasurer and so many of the same as shall not be taken by said Auditor in his capacity as such Treasurer shall be sold according to law, but for not less than par and accrued interest, and the proceeds from such sale, except any premium and accrued interest thereon (and the amount necessary for the payment of interest prior to the maturity of said notes), shall be paid into the proper fund and used for the purpose aforesaid and for no other purpose. Any premium and accrued interest (and the amount necessary for the payment of interest prior to their maturity) shall be transferred to the Bond Payment Fund to be applied in the payment of principal and interest of said notes in the mann or provided by law.

Section 8. Said notes shall be the full general obligations of the city, and the full faith, credit and revenue of said city are hereby pledged for the prompt payment of the same. The par value to be received from the sale of the bonds anticipated by said notes and any excess fund resulting from the issuance of said notes shall, to the extent necessary, be used only for the retirement of said notes at maturity, together with interest thereon, and is hereby pledged for such purpose.

Section 9. In the event that such assessments are not levied or bonds are not issued to provide a fund for the payment of said notes at maturity, a general tax shall be levied against all of the property in said city for the payment of such notes and the interest thereon.

Section 10. The City Auditor is hereby directed to forward a certified copy of this ordinance to the County Auditor.

Section 11. That this ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health

and safety, said emergency being that said street is in an impassible condition and dangerous to traffic and should be improved without delay, and said ordinance shall go into immediate force and effect.
