

ORDINANCE NO. 19-50

Granting permission to the East Broad Maryland Corporation to connect a lateral sanitary sewer with the 10 inch sanitary sewer located in Maryland Avenue, at the intersection of Roosevelt Avenue,

WHEREAS, the East Broad Maryland Corporation proposes to construct 164 family dwelling units in Rich Rod Addition in the City of Columbus, lying adjacent to and north of Maryland Avenue and east of Stanwood Road, and has requested permission of the City to connect a lateral sewer with the 10 inch sanitary sewer now in Maryland Avenue at the intersection with Roosevelt Avenue for the purpose of furnishing sanitary sewerage to said dwellings, and,

WHEREAS, it is estimated that the proportion of the cost to the City of Bexley of the construction of said 10 inch sanitary sewer which should equitably be borne by said East Broad Maryland Corporation, being in the proportion to said cost which said 164 dwelling units bears to the entire number of dwellings that will be served by said sanitary sewer, is the sum of \$1,061.60, NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That permission is hereby granted to said East Broad Maryland Corporation to connect a lateral sanitary sewer with the 10 inch sanitary sewer now in Maryland Avenue at the intersection with Roosevelt Avenue for the servicing of the 164 family units proposed to be constructed in the territory lying adjacent to and north of Maryland Avenue and east of Stanwood Road for the conducting of sanitary sewage into said 10 inch sanitary sewer, said connection to be under the supervision and to the satisfaction of the engineers of the City of Bexley.


Section 2. That a charge shall be made to said East Broad Maryland Corporation for the privilege of connecting into the said sanitary sewer in the sum of \$1,061.60, which sum shall be paid

to the City of Bexley prior to the making of such connection and the issuing of a permit therefor, said sum to be credited to the General Fund of the City.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
