To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments hereinafter set forth, for the current operation of the various departments herein shown, to wit:

(a) \$50.00 from the IC5 appropriation to the IC4 appropriation; \$500.00 from the 1E1 appropriation to the 1E2 appropriation; \$250.00 from the 1E4 appropriation to the 1E3 appropriation; \$50.00 from the 1E4 appropriation to the 1E6 appropriation; \$40.00 from the 1E5 appropriation to the 1E6 appropriation; \$75.00 from the 1I9 appropriation to the 1E8 appropriation; \$150.00 from the 1M3 appropriation to the 1M4 appropriation; \$150.00 from the 1M1 appropriation to the 1M5 appropriation.

(b) \$250.00 from the 2C3 appropriation to the 2C4 appropriation; \$50.00 from the 2C3 appropriation to the 2C5 appropriation; \$1,000.00 from the 2C1 appropriation to the 2C10 appropriation, in the Safety Fund.

(c) \$100.00 from the 3A3 appropriation to the 3A5 appropriation, in the Health Fund.

(d) \$50.00 from the 4C2 appropriation to the 4C8 appropriation; \$7,500.00 from the 4P7 appropriation to the 4P6 appropriation, in the Service Fund.

(e) \$500.00 from the 15B1 appropriation to 15B2 appropriation; \$100.00 from the 15B3 appropriation to the 15B6 appropriation, in the Park Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the Water Department:

(a) \$1,000.00 from the 6A3 appropriation to 6A4 appropriation; \$100.00 from the 6A3 appropriation to the 6A5 appropriation; \$2,000.00 from the 6F1 appropriation to the 6B1 appropriation; \$1,500.00 from the 6A3 appropriation to the 6B1 appropriation, in the Water Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Gasoline Tax Street Repair Fund to the appropriations herein set forth within said fund for the current operation of Street Repair department:

(a) \$1,000.00 from the 12A7 appropriation to the 12A6 appropriation, in the Gasoline Tax Street Repair Fund.

Section 4. That the sum of \$500.00 be reappropriated from the 18A2 appropriation within the Police Pension Fund to the 18A5 appropriation within said fund for the current operation of said fund.

Section 5. This Ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, in

the daily operation of the various city departments and the same shall go into full force and adoption upon the approval thereof.
