

ORDINANCE NO. 39-56

to reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said Fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$300.00 from the 1E3 appropriation to the 1E1 appropriation in the Jeffrey Mansion Fund.
- (b) \$175.00 from the 1E5 appropriation to the 1E2 appropriation in the Jeffrey Mansion Fund.
- (c) \$50.00 from the 1M1 appropriation to the 1M2 appropriation in the Recreation Fund.
- (d) \$100.00 from the 1M1 appropriation to the 1M4 appropriation in the Recreation Fund.
- (e) \$100.00 from the 2C3 appropriation to the 2C5 appropriation in the Safety Fund.
- (f) \$500.00 from the 2C10 appropriation to the 2C11 appropriation in the Safety Fund.
- (g) \$100.00 from the 3B1 appropriation to the 3A2 appropriation in the Health Fund.
- (h) \$200.00 from the 4C7 appropriation to the 4C5 appropriation in the City Hall Fund.
- (i) \$1200.00 from the 4O8 appropriation to the 4O9 appropriation in the Street Light Fund.
- (j) \$2000.00 from the 4P8 appropriation to the 4P6 appropriation in the Rubbish Collection Fund.
- (k) \$125.00 from the 15B4 appropriation to the 15B2 appropriation in the Parks Fund.
- (l) \$275.00 from the 15B4 appropriation to the 15B3 appropriation in the Parks Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the State Highway Improvement Fund to the appropriations herein set forth within said State Highway Improvement Fund for the current operation of the department.

- (a) \$100.00 from the 11A7 appropriation to the 11A11 appropriation within the State Highway Improvement Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Street Construction Maintenance and Repair Fund to the appropriations herein set forth within said Fund for the current operation of said Street Repair departments:

- (a) \$100.00 from the 12A8 appropriation to the 12A11 appropriation within said Street Construction Maintenance and Repair Fund.
- (b) \$2500.00 from the 12A6 appropriation to the 12A7 appropriation within said Street Construction Maintenance and Repair Fund.

Section 4. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operation of various city departments, and the same shall go into full force and adoption upon the approval thereof.
