

ORDINANCE NO. 23-57

To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

(a) \$400.00 from the 1E2 appropriation to the 1E1 appropriation in the Jeffrey Mansion Fund.

(b) \$100.00 from the 1E3 appropriation to the 1E1 appropriation in the Jeffrey Mansion Fund. (c) \$150.00 from the 1E5 appropriation to the 1E1 appropriation in the Jeffrey Mansion Fund.

(d) \$450.00 from the 1E6 appropriation to the 1E1 appropriation in the Jeffrey Mansion Fund.

(e) \$100.00 from the 1M5 appropriation to the 1M4 appropriation in Public Recreation Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Safety Fund to the appropriations herein set forth within said Safety Fund for the current operation of said Fund.

(a) \$150.00 from the 2C3 appropriation to the 2C4 appropriation in the Safety Fund.

(b) \$50.00 from the 2C6 appropriation to the 2C5 appropriation in the Safety Fund.

(c) \$100.00 from the 2C8 appropriation to the 2C5 appropriation in the Safety Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Health Fund to the appropriations herein set forth within said Health Fund for the current operation of said Fund.

(a) \$150.00 from the 3A2 appropriation to the 3B2 appropriation in the Health Fund.

Section 4. That the following sums be reappropriated from the various appropriations within the Service Fund to the appropriations herein set forth within said Service Fund for the current operation of said Fund.

(a) \$1500.00 from the 4P8 appropriation to the 4P9 appropriation within said Rubbish and Garbage Removal Fund.

(b) \$450.00 from the 15B1 appropriation to the 15B2 appropriation within said Park Fund.

(c) \$350.00 from the 15B1 appropriation to the 15B3 appropriation within said Park Fund.

Section 5. That the following sums be reappropriated from the various appropriations within the Street Construction Maintenance and Repair Fund to the appropriations herein set forth within said Street Construction Maintenance and Repair Fund for the current operation of said Fund.

(a) \$1000.00 from the 12A7 appropriation to the 12A8 appropriation within said Street Construction Maintenance and Repair Fund.

(b) \$100.00 from the 12A7 appropriation to the 12A13 appropriation within said Street Construction Maintenance and Repair Fund.

Section 6. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the water department.

(a) \$1000.00 from the 6B3 appropriation to the 6B1 appropriation within the Water Fund.

Section 7. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operation of various city departments, and the same shall go into full force and adoption upon the approval thereof.
