the several amounts reported as aforesaid, which assessments, together with the description of said lots and lands are now on file in the office of the clerk of this council, and which assessments are the actual cost to the City of Bexley for said repairs and are not in excess of the special benefits to said property and are not in excess of any statutory limitation.

Section 2. That the total assessment against each lot or parcel of land shall be payable in cash within three days from and after the passage of this ordinance, or, at the option of the owner, in two annual installments without interest. All cash payments shall be made to the Auditor of said City. All assessments and installments thereof remaining unpaid at the expiration of said three days shall be certified by the clerk of this council to the county auditor, as provided by law, to be by him placed on the tax duplicate and collected as other taxes are collected.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
