

ORDINANCE NO. 22-58

By Mr. Bell

To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$175.00 from the 1C5 appropriation to the 1C4 appropriation in Mayor Fund
- (b) \$300.00 from the 1E3 appropriation to the 1E1 appropriation in the Jeffrey Mansion Fund.
- (c) \$100.00 from the 1E3 appropriation to the 1E6 appropriation in the Jeffrey Mansion Fund.
- (d) \$200.00 from the 1M2 appropriation to the 1M4 appropriation in the Recreation Fund.
- (e) \$150.00 from the 1M3 appropriation to the 1M4 appropriation in the Recreation Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Safety Fund to the appropriations herein set forth within said Safety Fund for the current operation of the safety department:

- (a) \$100.00 from the 2C3 appropriation to the 2C1 appropriation within the Safety Fund.
- (b) \$100.00 from the 2C6 appropriation to the 2C1 appropriation within the Safety Fund.
- (c) \$150.00 from the 2C7 appropriation to the 2C4 appropriation within the Safety Fund.
- (d) \$500.00 from the 2C7 appropriation to the 2C8 appropriation within the Safety Fund.
- (e) \$400.00 from the 2C10 appropriation to the 2C8 appropriation within the Safety Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Health Fund to the appropriations herein set forth within said Health Fund for the current operation of the Health Department:

- (a) \$100.00 from the 3B1 appropriation to the 3B2 appropriation within the Health Fund.
- (b) \$150.00 from the 3A5 appropriation to the 3B2 appropriation within the Health Fund.
- (c) \$100.00 from the 3A3 appropriation to the 3B2 appropriation within the Health Fund.
- (d) \$150.00 from the 3A2 appropriation to the 3B2 appropriation within the Health Fund.

Section 4. That the following sums be reappropriated from the various appropriations within the Service Fund to the appropriations herein set forth within said Service Fund for the current operation of the Service Department:

(a) \$700.00 from the 4P8 appropriation to the 15B1 appropriation within the Service Fund.

(b) \$300.00 from the 4P8 appropriation to the 15B2 appropriation within the Service Fund.

Section 5. That the sum of \$350.00 be reappropriated from the 12A7 appropriation within the Street Construction, Maintenance and Repair Fund to the 12A13 appropriation within said fund for the current operation of said fund.

Section 6. That the sum of \$300.00 be reappropriated from the 4T9 appropriation within the Sewer Fund to the 4T8 appropriation within said fund for the current operation of said fund.

Section 7. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operation of various city departments, and the same shall go into full force and adoption upon the approval thereof.
