ORDINANCE NO. 30-61

To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$200.00 from the 1A5 appropriation to the 1A4 appropriation in the Council Fund.
- (b) \$25.00 from the 1B5 appropriation to the 1B4 appropriation in the Clerk of Council Fund.
- (c) \$1,000.00 from the Contingency Fund to the IC2 appropriation in the Mayor's Fund.
- (d) \$1,000.00 from the Contingency Fund to the 1D2 appropriation in the Auditor's Fund.
- (e) \$200.00 from the 1F5 appropriation to the 1F7 appropriation in the Solicitor's Fund.
- (f) \$1,500.00 from the 126 appropriation to the 125 appropriation in the Miscellaneous Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Safety Fund to the appropriations herein set forth within said Safety Fund for the current operation of the Safety Department.

(a) \$700.00 from the 207 appropriation to the 205 appropriation within the Safety Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Health Fund to the appropriations herein set for the within said Health Fund for the current operation of the Health Department.

- (a) \$250.00 from the 3A2 appropriation to the 3B2 appropriation within the Health Fund.
- (b) \$200.00 from the 3A3 appropriation to the 3A5 appropriation within the Health Fund.

Section 4. That the following sums be reappropriated from the various appropriations within the Street Construction, Maintenance and Repair Fund to the appropriations herein set forth within said Fund for the current operation of said Street Construction, Maintenance and Repair Department.

- (a)\$3,000.00 from the 12A6 appropriation to the 12A7 appropriation in the Street Construction, Maintenance and Repair Fund.
- (b) \$1,500.00 from the 12A6 appropriation to the 12A14 appropriation in the Street Construction Maintenance and Repair Fund.

Section 5. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the water department:

(a) \$200.00 from the 6A4 appropriation to the 6B3 appropriation within said Water Fund.

(b) \$500.00 from the 6Bl appropriation to the 6B3 appropriation within said Water Fund.

Section 6. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operations of various city departments, and the same shall go into full force and adoption upon the approval thereof.
