

ORDINANCE NO. 16 -63

An ordinance to provide for the issuance of bonds of the City of Bexley, Ohio, in anticipation of the collection of special assessments to pay the cost of the improvement of the west half of Gould Road between Broad Street and Main Street.

WHEREAS, this Council has requested the City Auditor to issue his certificate as to the estimated life of the property, asset or improvement proposed to be acquired or constructed from the proceeds of the bonds hereinafter referred to, and the City Auditor has certified to this Council such estimated life as exceeding five years and has further certified the maximum maturity of such bonds as ten years; and

NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

SECTION 1. That it is deemed necessary to issue bonds of the City of Bexley, Ohio, in the principal sum of Forty-six Thousand (\$46,000.00) Dollars, in order to provide a fund for the payment of the note previously issued to pay the cost of the improvement of the west half of Gould Road from Broad Street to Main Street, which note will mature September 1, 1963.

SECTION 2. One of said bonds shall be in the denomination of Five Thousand Five Hundred (\$5,500.00) Dollars, numbered 1, and nine of said bonds shall be in the denomination of Four Thousand Five Hundred (\$4,500.00) Dollars, each numbered consecutively, from 2 to 10, both inclusive and all shall be dated September 1, 1963, and shall bear interest at the rate of 3-1/2% per annum, payable semi-annually on the first days of June and December of each year, commencing June 1, 1964, until the principal sum of said note is paid, provided, however, that if said bonds are sold bearing a different rate of interest than herein specified, such bonds shall bear such rate of interest as may be provided for in the resolution of Council approving the award thereof. Said bonds shall mature as follows:

\$5,500.00 on the first day of December, 1964, and \$4,500.00 on the first day of December in each of the years 1965 to 1973, both inclusive.

It is hereby determined that the foregoing maturities are in substantially equal amounts. The principal and interest of all said bonds shall be payable at the Town and High Office of The Ohio National Bank of Columbus, Columbus, Ohio.

SECTION 3. That said bonds shall express on their face the purpose for which they are issued; that they are issued in pursuance of this ordinance and shall be signed by the Mayor and Auditor, and sealed with the corporate seal of said City. The proper interest coupons bearing the facsimile signature of the Auditor shall be attached to and made a part of said bonds.

SECTION 4. That for the purpose of providing the necessary funds to pay the interest on the foregoing issue of bonds promptly, when and as the same falls due, and also to provide a fund sufficient to discharge said bonds at

maturity, there shall be and is hereby levied on all the taxable property in said City of Bexley, in addition to all other taxes, a direct tax annually during the period said bonds are to run in an amount sufficient to provide funds to pay interest upon said bonds as and when the same falls due and also to provide a fund for the discharge of the principal of said bonds at maturity, which tax shall not be less than the interest and sinking fund tax required by Article XII, Section 11 of the Constitution; provided, however, that each year the assessments anticipated by said bonds are payable and are applicable to the payment of such interest and principal and are appropriated for such purpose, the amount of such tax shall be reduced by the amount of the assessments so appropriated.

Said tax shall be and is hereby ordered computed, certified, levied and extended upon the tax duplicate and collected by the same officers, in the same manner and at the same time that taxes for general purposes for each of said years are certified, extended and collected. Said tax shall be placed before and in preference to all other items and for the full amount thereof. The funds derived from said tax levies hereby required shall be placed in a separate and distinct fund, which together with all interest collected on the same, shall be irrevocably pledged for the payment of the interest and principal of said bonds when and as the same fall due.

SECTION 5. That said bonds shall be first offered at par and accrued interest to the Officer in charge of the Bond Retirement Fund and if refused, then said bonds shall be sold in the manner provided by law under the direction of the auditor; the bond sale advertisement shall state that anyone desiring to do so may present a bid or bids for such bonds based upon their bearing a different rate of interest than hereinbefore fixed, provided, however, that where a fractional interest rate is bid, such fraction shall be one quarter of one per cent, or multiple thereof; the proceeds from the sale of said bonds, except the premium and accrued interest thereon and the amount of said bonds issued for interest shall be used for the purposes aforesaid and for no other purpose; the premium and accrued interest received from such sale and the amount of said bonds issued for interest shall be transferred to the Bond Payment Fund to be applied in the payment of principal and interest of said bonds in the manner provided by law.

SECTION 6. It is hereby determined that all acts, conditions and things necessary to be done, precedent to and in the issuing of these bonds in order to make them legal, valid and binding obligations of said city have been done, performed and have happened in regular and due form as required by law; that the faith, credit and revenue of said city are hereby irrevocably pledged for the prompt payment of the principal and interest thereof at maturity and that no limitation of indebtedness or taxation, either statutory or constitutional, has been exceeded in issuing these bonds.

SECTION 7. The Auditor is hereby authorized and directed to certify a copy of this ordinance to the Auditor of Franklin County, Ohio, according to law.

SECTION 8. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
