Section 2. That the owners of all lots and lands bounding and abutting upon the proposed sidewalks shall repair in accordance with plans and specification as set forth in Ordinance No. 11-48. The portion of such sidewalks abutting on their respective properties within a period of forty-five (45) days after service of notice of this resolution; and, if such repair shall not be completed within such period of forty-five (45) days, then this Council shall have the same done and the entire cost thereof shall be assessed upon the property of each defaulting owner and made a lien thereon, to be collected in the manner provided by law with penalty and interest as provided by law.

Section 3. That the Clerk of this Council is directed to cause a written notice of passage of this resolution to be served as required by law.

Section 4. The plans specifications and estimate of cost of said repair as heretofore filed are hereby approved.

Section 5. This resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health and safety and for the further reason that the immediate repair of such sidewalks is urgently required to permit safe passage by persons using said sidewalks and to eliminate existing hazards to pedestrians; Wherefore this resolution shall be in full force and effect in and immediately after passage.
