

ORDINANCE NO. 29-64

To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$300.00 from 1M1 to 1M5 in the Recreation Department Fund.
- (b) \$150.00 from 1M2 to 1M5 in the Recreation Department Fund.
- (c) \$500.00 from 1Z3 to 1Z4 in the General Fund.
- (d) \$300.00 from 4C8 to 4C5 in the Service Fund.
- (e) \$1000.00 from 4O8 to 4O9 in the Service Fund.
- (f) \$350.00 from 4O7 to 4O9 in the Service Fund.
- (g) \$500.00 from 4O8 to 4O9 in the Service Fund.
- (h) \$2000.00 from 4P8 to 15E1 in the Service Fund.
- (i) \$600.00 from 4P8 to 15B3 in the Service Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Health Fund to the appropriations herein set forth within said Health Fund for the current operation of the Health department.

- (a) \$100.00 from 3A3 to 3A4 in the Health Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Street Construction, Maintenance and Repair Fund to the appropriations herein set forth within said Fund for the current operation of said Street Repair department.

- (a) \$2000.00 from 12A7 to 12A8 within said Street Construction, Maintenance and Repair Fund.
- (b) \$200.00 from 12C8 to 12C9 within said Street Construction, Maintenance and Repair Fund.

Section 4. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the water department.

- (a) \$300.00 from 6B3 to 6A4 in the Water Fund.

Section 5. That the following sums be reappropriated from the various appropriations within the Sewer Fund to the appropriations herein set forth within said Sewer Fund for the current operation of the sewer department.

- (a) \$1500.00 from 4T3 to 4T4 in the Sewer Fund.
- (b) \$ 500.00 from 4T8 to 4T4 in the Sewer Fund.
- (c) \$1500.00 from 4T7 to 4T4 in the Sewer Fund.

Section 5. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operation of various city departments, and the same shall go into full force and adoption upon the approval thereof.
