

ORDINANCE NO. 28-65

To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$75.00 from 1E5 to 1E4 in the Jeffrey Fund.
- (b) \$200.00 from 1M1 to 1M2 in the Recreation Department Fund.
- (c) \$50.00 from 1M5 to 1M3 in the Recreation Department Fund.
- (d) \$200.00 from 2C5 to 2C3 in the Safety Fund.
- (e) \$100.00 from 2C5 to 2C4 in the Safety Fund.
- (f) \$100.00 from 2C8 to 2C10 in the Safety Fund.
- (g) \$1000.00 from 4O8 to 4O9 in the Service Fund.
- (h) \$500.00 from 4P6 to 4P7 in the Service Fund.
- (i) \$200.00 from 15B2 to 15B1 in the Service Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Street Construction Maintenance and Repair Fund to the various appropriations herein set forth within said Fund for the current operation of said Street Repair department.

- (a) \$500.00 from 12A7 to 12A11 within said Street Construction, Maintenance and Repair Fund.
- (b) \$100.00 from 12C7 to 12C8 within said Street Construction, Maintenance and Repair Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the water department.

- (a) \$1000.00 from 6A1 to 6F1 within said Water Fund.
- (b) \$ 200.00 from 6A4 to 6F1 within said Water Fund.
- (c) \$ 200.00 from X6J23 to X6H22 within said Water Fund.

Section 4. That the following sums be reappropriated from the various appropriations within the Police Pension Fund to the appropriations herein set forth within said Police Pension Fund for the current operation of the Police Pension department.

- (a) \$100.00 from 18A2 to 18A5 within said Police Pension Fund.
