That the Mayor and the Auditor be and they hereby are authorized and directed, after advertisement according to law, to enter into a contract for the installation and construction of new street lights on East Main Street and East Broad Street conforming to the plans and specifications prepared by Metzger and Blackburn and outlined in Section 1 of this ordinance.

Section 3. That the sum of \$85,000.00 is hereby appropriated from the General Fund for the purpose of paying the cost of said new lights.
